1. THE PURPOSE, THE SUBJECT, PROBLEMS AND AGREEMENT TERM:

1.1. Realization economic-the legal project "LIFE" on protection constitutional and a civil freedom of payers of taxes. Political and economic association of the country on the basis of the developed ideological and economic-legal project of creation «All-Ukrainian Party of Payers of Taxes» (A-UPTP), its subsequent occurrence in the World Assembly of Parties of Payers of Taxes (WAPTP). Realization of the target Transnational social, economic-legal project "LIFE" on introduction of High Technologies, creation of new highly paid workplaces in Ukraine.

The present Public Agreement of tax bearers of Ukraine and the World states is concluded for the purpose of cooperation of Partners, development of national values, realization of the joint economic-legal projects uniting tax bearers of the countries on an ideological platform.

The International Ecological Project «Peace Hydrogen and Energy» and the Project of creation of the International Technical Consortium «New Ecological and Energy Projects» at the first stage will create the economically self-sufficient home market of High Technologies, manufacturers of the goods, works and services in each country. At the second stage will generate the uniform external economically self-sufficient market «High Technologies», manufacturers of the goods, works and services, with participation of economy of the EU countries, CDC, BSEC, BRICK, APEC. The given market person in which territory all modern Projects in area of "High Technologies», the Program «Atomno-Hydrogen, hydrogen, alternative, renewed power and fuel elements, nanotechnology and nanomaterial» will be realized will unite the developed states of a planet with the population more than 4, 6 billion, including on a diversification of energy sources in a transition period from hydrogen power to hydrogen economy by preparation of each state for participation in the International Ecological Project «Peace Hydrogen and Energy» and to the decision of various International environmental problems, on prevention of climate change of a planet.

Basic creation of diversified manufacture, introduction of a national and transnational intellectual product and new technologies in an everyday life, will allow to soften a problem of a world economic crisis, and at the expense of power savings, considerably to lower cost on energy carriers, to create already today for each country of a condition of overcoming of world financial crisis. Cost of energy carriers is reflected in economy of any state. Reduction of price on energy carriers very important for each country, depends on its cost well-being of own people and the population of all planet.

Presented the International Ecological Project «Peace Hydrogen and Energy», the Project of creation of the International Technical Consortium «New Ecological and Energy Projects», at association of the world capital of the states of EU, CDC, BSEC, BRICK, APEC will allow to solve problems of the Kiotsky report:

1. To create uniform economic space in the field of introduction of "High Technologies», the Program «Atomno-Hydrogen, hydrogen, alternative, renewed power and fuel elements, nanotechnology and nanomaterial». Including on a diversification of energy sources in the Transnational Project with participation of economy of all interested countries.
2. Independent international expert estimation of cost of organizational non-material actives, is spent by experts of Commercial and industrial chamber of Ukraine (<http://www.kiev-chamber.org.ua/uk>) with attraction of world famous estimated firm American Appraisal (AAR), Inc. (<http://www.american-appraisal.ru>), and also appraisers of All-Ukrainian public organization «Association of Experts of the Estimation» (<http://afo.com.ua>), Estimation and Right Academies (<http://www.akadem.com.ua>), and «Societies of Strategic Researches» (Berlin, Germany).

As a result of carrying out of an independent international expert estimation by experts, it is established that cost of the organizational non-material actives executed by initiative group of creation of forming infrastructural divisions of the International Technical Consortium «New Ecological and Energy Projects» (ITC «NEEP») the International Ecological Project «Peace Hydrogen and Energy» (IEP «PHE»), makes more than 150 000 000 EURO.

By results of the executed independent international expert estimation, and also following the results of the spent international seminars, negotiations with participants IEP «PHE», the Project of creation ITC «NEEP» and it gel-forming the enterprises, the decision of the basic strategic investors, founders, sponsors and partners that is accepted:

1. The Authorized capital of structures ITC "NEEP" and Corporation created of cost of contributions of the Shareholders brought as a result of acquisition by them of actions, will make 1 500 000 000 (one billion five hundred millions) EURO. Corporations are created on the territory of the country participating in realization of the International Ecological Project «Peace Hydrogen and Energy».
2. Total cost of the nominal "Platinum" action of Corporation makes 1 000 000 (million) EURO.
3. The Face-value of one let out action of national and transnational Corporation makes 100 000 (hundred thousand) EURO.

High technologies are a real step to development of power dialogue, overcoming of a world economic crisis and reform of the international financial institutions. World economic, ecological and the energy crisis has provoked chain reaction all over the world. Global economy and economy of all states collapse.

Strategic social and economic programs, bank systems fall. There comes the moment of general chaos. We lose the stable past; it at us already is not present. The mankind future in doubt, and the present if it not to comprehend and not to transform at the expense of realisation of the program of high technologies of project IEP «PHE» and creations ITC «NEEP», will lead mankind to new unpredictable tragedies already today. In the state all strategic questions and furthermore safety issues of the country and its citizens need to be solved cardinally, and in the shortest terms.

Will allow each state for the account «High Technologies» to constrain price appetites of monopolists in the market of energy carriers:

- For the electric power - 1kvt/ch, the estimated cost price 0,00513 EUROS;
- For natural gas - 1000 м³ (in recalculation on hydrogen - 4000 м³), the settlement cost price 10 EUROS.

The International Ecological Project «Peace Hydrogen and Energy», provides creation of the International Technical Consortium «New Ecological and Energy Projects» (ITC «NEEP»), formation and creation of the international organizations, infrastructural divisions and managing subjects on purpose:

The corporations "Hudrogenatom mashpromenergo-nanotechmat" and Joint-Stock Company of National Investment Corporation of High Technologies «Nanotechnology Initiatives and Manufacture Nanomaterial» (J-SC NIC HT "Nanotehmat"), for advancement and realization of project IEP «PHE» in each country to the participant.
- Introductions of modern technologies on a diversification of energy sources under the program «the Atomno-hydrogen and hydrogen power, alternative, renewed energy sources and fuel elements, nanotechnology and nanomaterial».

- *If use hydrogen as fuel, possibility of strengthening of a hotbed effect is excluded, harmful substances are not allocated; there is no danger of formation of stagnant zones of hydrogen.

Thus officials, so-called political elite of the country, declaring that the power in the country belongs to the people, really owning the power, have made us the slaves in our state. To finish it, we should struggle for the rights and freedom. Voluntary to dominate over us and to plunder us, officials will not stop.

Political parties are necessary to officials for discharge of the people from its real power and its deduction in the hands. The power chaotically passes from one robbers to another, from one hands in others.

Through the power officials provide the economic well-being at the expense of tax bearers, preservation and augmentation of the stolen national good.

The high-ranking officials, use the office position, direct financial streams through the commercial structures over which their relatives supervise, exhaust municipal payments and budgetary national money in the banks through which them then wash.

Tax bearers in Ukraine sell the work for penny and receive salaries in 5-7 times less, than in developing countries. Tax bearers have inflation, the world prices for essential commodities, and taking into account inflation officials from the power have world salaries only.

Any of parties of officials cannot tell that their party unites all those who is an economic basis of the state and a perennial spring of filling of the budget of the country, unlike A-UPTP.

All parties of officials bring split in a society, these parties sectoral. They cover those voters who it was on sale, or the official in something is guilty to "Owner". They have no ideology; they do not have national roots, all in words, except desire of their leader and the leader to sit down in that, or other, an armchair.

They use work of tax bearers and their earned money. They establish and dictate the sums of taxes and penalties, invent new various payments and taxes to the maintenance. Officials use the people for the decision of the mercantile questions, and the main thing, for finding through tax bearers of the power in the country.

Officials in Ukraine create new workplaces, only for themselves, but not for the working people. It is necessary for owners of parties, high officials from the power already today to buy votes in those regions where they have put the representatives. Through attraction of an administrative resource (vassals - officials), for gathering of voices in support of the necessary candidate on elections, they do the dirty work.

New workplaces in real sector of economy the Government, the President, have not created political parties of the country and will not create in the future. National money leaves on struggle with the people and on financing of opposition of parties in a society.

Tax bearers of Ukraine are an economic basis of the state and a source of formation of the budget of the country. They form political, economic, legal and defensive potential of any state.

They are a perennial spring of economic development, prosperity and power of the country.

Labour tax money in hands of greedy officials has finished the country to crash and has created intolerable conditions of a slavish life in the country. The maintenance of officials should be by a residual principle. After drawing up of the social budget, tax bearers of Ukraine should define, how many they can contain officials in the state and what should be their salary.

If Ukraine cuts down the expenses on the maintenance of 90 % of officials in the country all social problems will dare, and the state economy will sharply grow. Take care of the pence, the pounds will take care of themselves, and we contain weight of such officials which create to us and our children, the family only problems in our life for our blood money.

Officials it is necessary to reduce and transfer urgently them from non-productive sector of economy, in real, self-sufficient industrial sector, for development of new modern technologies on decrease in the cost price of production and increase in profitability of manufacture. Revival of labour dynasties in hot manufacture, machine-tool construction and mechanical engineering, chemical and oil refining manufacture, farmer and an agricultural production, park of sea and transshipment transport.

We, of course, understand that a question of manufacture and introduction of a national transnational intellectual product, revival of labour dynasties of a hot grid, in connection with a reshaping of patriotic national labour shots in sellers of the foreign sub-standard goods on trays of the markets and markets, for 5-7 GR at an o'clock, is problematic. As popular wisdom speaks, "Donkey" stood in a shade, on the sun will not work. But ломка tax bearers of the consciousness lost by the people of its country, because of the insolvent and worthless power, it is inevitable. Otherwise, tax bearers and the country people, seeing vulnerability of the rights and freedom, will dethrone the exploiters and in this case before civil war in any country, because of avidity and corruption of officials becomes much closer, no distance. Because of officials and their parties, the world conflict in any modern society with the people develops.

For this purpose it is necessity stolen and taken illegally away construct in the country new factories, to create, on manufacture at development of the High Technologies, new highly paid workplaces for the population of the country and the reduced officials from the former power. Tax bearers should bring up shots from A-UPTP and direct to the power as the fighters on the permit from party, and strictly to ask from them for omissions in the entrusted work. Tax bearers of the country, are connected from time immemorial by struggle against the eternal enemies greedy and corrupted by officials!

Tax bearers in the world it is an economic basis of any state a source of filling of the budget of the country, a guarantee of economic power, development and prosperity.

- To take part in the organization of the first congress on creation A-UPTP and elections of the supreme bodies of Party, according to the coordinated scheme of formation A-UPTP;
 - To provide participation in financing of preparation of all materials and actions for carrying out of first congress A-UPTP, for the account of means of the Tax bearers, the coordinated payments and in advance arrived on the CENTER account;
 - If necessary at the expense of collective means to provide financing; urgent educational preparation and completion by shots of Organizing committee, the Central staff A-UPTP at forthcoming elections of directing bodies of party, it agree the List of staff under the scheme of elections and to conclude Contracts on rent of office areas in regions to 50 sq. meters, in regional organizations to 150 sq. meters and in the central staff A-UPTP at a rate of not less than 250 sq. meters and not less than 10 rooms within 14 calendar days from the moment of the beginning of deployment of the planned works as organizing committee on creation A-UPTP and receipts in advance coordinated the sums into the account of the CENTER from Tax bearers of participants of the Project "LIFE";
 - To provide creation and registration of the regional party organizations with name A-UPTP; after registration in Ministry of Justice of Ukraine of new Party (A-UPTP) and election of the supreme bodies of Party (A-UPTP), for the account of means of Tax bearers in the volumes which coordinated with the Center and have in advance arrived into the account of the Center for financing of creation A-UPTP;
 - From the moment of registration of the developed Party charter and Program A-UPTP Ministry of Justice of Ukraine; the state registrar and Goskomstat of Ukraine to provide creation of the party organizations, to spend formation of the regional and local organizations it agree schemes of formation A-UPTP new ideological platforms of electorate A-UPTP in regions of Ukraine under specially developed program A-UPTP, signings of the Public Agreement of Tax bearers of transfer and receipt of the coordinated means for the Center account;
 - To provide stable financing on creation of Projects, Plans and Programs of pre-election actions A-UPTP. To organize calculations of expenses at elections in the country of the President of Ukraine and Parliament for the coordinated financing by Tax bearers and sponsors through the Center, and further and at the expense of membership dues
- A-UPTP;
- To take active part in elections of Parliament and the President of Ukraine, under the confirmed Plan of work and the Program of pre-election actions A-UPTP;
 - To provide creation of projects, business of the Plan and Program of pre-election actions, inside of party and calculation of expenses outside of A-UPTP; at elections of People's Deputies of Ukraine for the coordinated financing by the Organization and sponsors. To take part in elections of People's Deputies of Ukraine;
 - To provide our help to the regional and local party organizations in creation of projects of the Plan and Program of pre-election actions. On places, calculation of expenses at elections of local deputies and chairmen of cities, settlements and

villages in Ukraine and coordinated financing by tax bearers and sponsors, to take part in these elections help to the regional and local party organizations;

- To lead formation of Lists of candidates in People's Deputies of Ukraine and local bodies of deputies;
- To take active part in creation « The global-regional concept of the device and state Ukraine existence » and « Programs of a reorganization of the state Ukraine» on the basis of this concept. And also the new constitution of Ukraine, laws on duties and the rights of authorities, on an estimation of activity and responsibility of authorities etc.;
- To develop, expand and strengthen together with the Center organizational and executive structures of Party (A-UPTP), to form authorized bodies of Party (A-UPTP);
- Together with the Center to develop, organize and spend preparatory measures A-UPTP for participation in elections of People's Deputies to the Supreme Rada of Ukraine, local councils, and also city, settlements and rural Chairmen. To create and form selective organizational structures and lists of candidates in People's Deputies of the Supreme Rada of Ukraine, local councils, to conduct up to election and pre-election actions A-UPTP and to participate directly in elections;
- Together with the Center to conduct the activity which is not contradicting the Charter. The purposes and problems, Program documents and Party decisions (A-UPTP), in the Supreme Rada of Ukraine, local councils, and also city, variety and rural Chairmen, passage of candidates A-UPTP accordingly in the Supreme Rada, local councils and city, variety and rural Chairmen;
- Together with the Center to take part in formation of the central and local enforcement authorities;
- Together with the Center to take part in formation and realization external and internal policy of the state, a political policy of Ukraine;
- Together with the Center to develop, organize and realize charitable, information, organizational, protest and other actions;
- To accept from the Center of the offer and the remark on the above-stated questions and accordingly to them to react.

2.2 CENTER UNDERTAKES:

- To provide qualitative reception; of financial assets into the Center account in the coordinated sum within 3 calendar days from the moment of signing by Partners of the given Public Agreement, for preparation and a party creation, carrying out of first congress A-UPTP, rent of the central office of Party (A-UPTP), payments of work of members and employees of Organizing committee of a party creation (A-UPTP), financing of creation of the regional party organizations, to registration of registration certificates A-UPTP, the seals, carrying out of propaganda work with electorate on creation A-UPTP to provide participation of Tax bearers - delegates of first congress A-UPTP in formation of shots, to direct under the recommendation of members A-UPTP of worthy representatives to the Party supreme bodies;
- To provide formation by Tax bearers regional and local party the organizations according to the scheme;

- To provide participation of Tax bearers in work with "electorate" under the special program;
- To accept means and to do a payment of membership; dues to the Center and provide also financing of pre-election actions and Party A-UPTP staffs on presidential elections of Ukraine, People's Deputies of Ukraine, deputies of local councils, chairmen of cities, settlements and villages, referenda, it agree confirmed articles of expenses, for the account of receipt of means for the account of the Center and participation of sponsors;
- To provide financing; of authorized activity A-UPTP: at the first stage to equip offices with the equipment, office equipment, furniture and other property, to conduct payment of rent, the electric power, water and utilities, payment of the salary to employees of the central bodies of Party A-UPTP, the regional and local party organizations, it agree the estimates of expenses coordinated and confirmed by congress, and also for the account of means collected by the Center and the arrived money from sponsors its account;
- To take part together with Tax bearers in development, expansion and strengthening of organizational and executive structures of Party (A-UPTP), formation of authorized bodies of Party (A-UPTP);
- At each party organization to create branch of the Center of protection of the rights and freedom of payers of taxes "LIFE", on rendering free consulting and a legal aid to tax bearers on protection of their constitutional laws and a civil freedom in various instances.
- Together with Tax bearers to take part in working out, the organization and carrying out of preparatory measures for participation in elections of People's Deputies in the Supreme Rada of Ukraine, the President of Ukraine. To take part in elections in local councils, city, variety, rural Chairmen, in creation and formation of selective organizational structures and lists of candidates in People's Deputies in the Supreme Rada of Ukraine and local councils, conducting up to election and pre-election actions with the assistance of Tax bearers;
- Together with Tax bearers to do conduct the activity; which is not contradicting the Charter, the purposes and problems A-UPTP, to Program documents and Organization decisions, in the Supreme Rada of Ukraine, local councils, and also city, variety and rural Chairmen, in case of passage of candidates of the Organization under Party lists accordingly in the Supreme Rada, local councils and city, variety and rural Chairmen, in the borders of participation coordinated with Party;
- In common with sponsors and to Tax bearers to provide constant financial, material, charitable and other help, donations on assistance on development A-UPTP;
- Together with Tax bearers to take part in formation of the central and local enforcement authorities;
- Together with Tax bearers to take part in working out, the organizations and realisations of charitable, information, organizational, protest and other actions, in the borders of participation coordinated by the Parties;
- Together with Tax bearers to take part in formation and realization external and internal policy of the state, a political policy of Ukraine;
- To give a priority to Tax bearers in the decision of social problems to party members in the country, abroad and at the international level;

- To support legislative initiatives of Tax bearers, party members, at the decision of questions at the President, in the Supreme Rada, the Cabinet, the central and local authorities;
- To render the charitable help together with Tax bearers within the limits of the Project "LIFE", to project public organizations in financing of their authorized activity and Programs.

2.3. The centre of protection of the rights and freedom of payers of taxes "LIFE" and Tax bearers as Partners undertake to carry out and achieve from the state of performance for tax bearers of citizens of the country, invalids, veterans of work, war and Armed forces, participants of war and the operations, the following obligations defined by the law:

- Full, timely and unconditional realisation of laws of Ukraine about their social protection;
- Strict target use of the public funds directed for them by the state budget of Ukraine and local budgets;
- Full and timely payment of salaries by them, pensions, grants, indemnifications, surcharges and other payments;
- Full repayment of debts by them on pensions, indemnifications and payments, and an interdiction of its formation further;
- Timely and full indexation of their pensions, indemnifications and payments according to inflation;
- Proportional increase in their pensions, indemnifications and surcharges because of change of a cost of living index, increase of the minimum salary and the minimum pension;
- Grantings of the minimum pensions not below the established living wage;
- Timely granting requiring habitation, creation of the state housing programme for this category of the population;
- Full free and effective maintenance with their health services, treatment, prosthetic dentistry, rehabilitation actions and medicines, and medical and rehabilitation establishments, their serving - necessary state financing and the equipment;
- Full, timely and according to disease of their free improvement and sanatorium treatment or payment of indemnification by them for not spent improvement and sanatorium treatment at a rate of average cost of the improving or sanatorium permit in Ukraine;
- Creations for them an infrastructure of the preferential enterprises and assistance of their activity;
- Assistance of activity to public organisations and the welfare funds created by this category of the population, carrying out with them joint actions;
- Their urgent indemnification, depreciated in 1991-1992, labour savings;
- The organisations of the large-scale constant international help and cooperation on liquidations of consequences of Chernobyl accident, creation in Ukraine of for this purpose corresponding conditions;
- The constant, effective and public control over the decision of their problems and the reporting;
- Maintenance of cooperation of the public organisations created by this category of the population, with state structures, creation with them the joint Advisory

councils at the President, the Supreme Rada, the Government, the ministries and other central and local authorities

- Creation is private - the state international infrastructure of the economic-legal project "LIFE" in the countries of the world for the decision of social problems in a society, (branch of Limitless Bank, branch of Investment Fund, branch of Insurance company "LIFE", the Center of training of a trade "LIFE", the Business incubator "LIFE", mediko-rehabilitation Center "LIFE", the Centers of socially-psychological rehabilitation "LIFE", etc.), and also abroad to create infrastructures at the international level with participation of 84 countries of the world, participants of the project.

3. RESPONSIBILITY OF PARTNERS:

3.1. The centre of protection of the rights and freedom of payers of taxes "LIFE" and Tax bearers as PARTNERS bear responsibility according to the current legislation of Ukraine.

PARTNERS make all joint decisions connected with performance of the present Public Agreement, on principles of a consensus and the full consent.

All disputes arising in the course of performance of the present Public Agreement, PARTNERS resolve peacefully, by negotiations.

3.2. In case, if the sum of transfer of means for the Center account, and further A-UPTP, coordinated between PARTNERS in the Appendix №1, will not be listed by the Tax bearer into the account of the Center within 3 calendar days from the moment of signing of the present Public Agreement and the appendix to it the given Agreement is considered VOID AUTOMATICALLY.

3.3. All additions, appendices and changes to the present Public Agreement consist in writing, are confidential, subscribe the authorized representatives of the Center and the Tax bearer, are fastened by signatures and the seals, and are an integral part of the given Public Agreement.
