The Public Chamber of the Ukraine – Presidential branch authorities (the upper chamber) is elected national by voting for 12 years, but from her composition is elected president of the country in two aurochs, on 3 years. Under efficient functioning (working) the President his re-elect, but otherwise elect new more eager. These changes are to Constitution necessary to put into installed order. This is a collective organ at period between choice chapters state, forms the kernel of the Presidential command, in too time they have responsibility for actions of the President if required they can his call back and reelect. Thereby, at purpose main managers of the country, on state management, we shall be a mistake-proof separate personalities and creation corrupt encirclements, lickspittle and toady. We must it is correct to value the role of the personality in histories state and prevent the possible mistakes. Thereby, President and his command is a collective organ, competent state official, which declaim for assertion state and public interest, present the interests of folk all over the world from folk by proxy. Thereby, we shall be mistake-proof one person and influences upon it his unhealthy encirclement, under all-round development of the country and shaping created society. Folk of the Ukraine cannot be a hostage, mercantile interest of one person, in fight for power leader-President with created by him encirclement, with own folk, with Sovereign Radium and with Government of the Ukraine. The politicians defend its rightness and ideas in dialogue with opponent and come to a conclusion on disputable questions and normative acts - a voting. Presidents, Vice Presidents, Ministers and officials high rank, for the reason preventions of the abuses, must be elected in bicameral parliament on joint meeting of the chambers. On length of the histories of the new Ukraine all Presidents got under influence created by them own encirclement and under influence of the leaders of the different foreign countries, never had a possibility to conduct independent internal and external politician in interest of own folk.

Runs away level of the inflation processes, chronic nature has taken the deficit of the pension budget, fall capacity of the labour and salary. Herewith remain the obvious multiple undecided problems of the connecting period, to which are added and such:

Form bicameral parliament in composition:

a) Sovereign Pleas;

b) Chamber Region;

The amount deputy in both chamber equal – on 250 deputies.

In administrative – state device of the Ukraine A-UPPT considers expedient to go to principle federative with following fission:

- An Edge "West Ukraine";
- An Edge «East Ukraine»;
- An Autonomous republic «Crimea».

Regional fission is saved in edge. The high power in edge belongs to their Supreme Soviets, electing executive power on behalf of President of the Edge and Government. The local organs of the home rule in all three federative units alike. In jurisdiction of the marginal Supreme Soviets enters lawmaking activity regional level. No objections, against economic cooperation with Europe on equal, but for this we must economy of the country to raise on level of the developed countries of the west in its development to not to become the raw materials appurtenance and country where are used forbidden in Europe to ecological bad technologies. State and market institutes do not answer the modern task of the modernization. The majority enterprises have technologically grown old, have endured not a single period physical and obsolescence in recent years. As a result this, plants, large industrial objects without modernization and repair stop its functioning and die. Today, in breach all concluded agreements with fund property Ukraine, about modernizations and conservations worker places, plants are cut on scrap metal, throwing people on street, grows criminality, robberies, thefts in region, do not dare the social questions a retiree, invalid, sick children, veteran, no reproducing the population, fell birth rate, folk of the country is found on galley proof extinction and destruction. Possible speak about cultural value with folk on satisfied belly, but in many family of no bread today, not for that to buy the medicine sick relative, but public money are spent unadvisedly, unbeknown payer of the taxes. The crisis of the defaults on a payment, absence of the circulating assets, increase the share of the dark sector of the economy, reduction content home market, unbeatable of the price on raw material, inefficacy of control privatized enterprise and non-performance new owner, terms social warranty toiling, dictate monopolist, continue to bring about bankruptcy all new and new plants and factories. On, former low financial facilities and power of the labour in state, absence of the gross product and protection of the domestic producer. Goods are bought abroad, than are supported that producers, but our production definitively perishes. Beside majority enterprise, level of the production expenses such that Ukraine, possessing significant resource, feels constant their deficit. A-UPPT considers the serious error acting authorities premature entering the Ukraine in WTO at any cost, because modern condition is given birth economic complex, under which has occurred this entering, else stronger has complicated the position of the

domestic commodity producer, open Ukrainian market for the second-rate product of foreign funds. Appeared the threats of national safety to Ukraine in economic sphere, amongst which specifically dangerous are such trends, as:

- growing before critical level internal and external state debt;
- the GDP reduction , vagary financial politicians;
- the crisis of the balance of payments and overhanging danger on Ukraine default;
- the conversion of the economy of the country in field of the battle oligarchies clan;
- the reality of the destruction and stops scolded sector of the economy.

The Ukraine steadily loses even traditional market for itself. Financial-credit system inefficient. Wheel inflations are untwisted. Grows economic criminality, connected with runaround from payment of the taxes, contraband, bribetaking and extortion official so named «recoil», introduction in economic relations subject managements of the criminal financial schemes. Technological backlog from developed countries continues to increase. All these problems and first of all, inattention government to reduction industrial complex of the Ukraine, including state sector of the economy, Have brought the country to heavy economic crisis and destruction of the system social warranty for folk. The Political Parties represented in Supreme Soviets and Government of the Ukraine, have not been able to provide the development of the national programs and making the legislative basis of the rebirth of the national economy, before extremity unstable today and disbalances. Coming from foregoing, with determination of the public nature authorities, A-UPPT considers necessary to realize the Following priority actions on refining economy of the Ukraine: conduct the general state inventory of the production capital funds of the country and passport system enterprise of all property categories.

A-UPPT considers that today is absolutely motivated, with legal standpoint, stating the question about return Ukrainian folk his national possessions. This be based on constitutions of the Ukraine and on positions of the general declaration of the rights folk, stating that «each folk have a suit rights on their own national wealth and facility, right on their return if they were plundered». Recovering the constitutional rights of folk of the Ukraine on national possessions, impossible without investigation circumstance privatization, as from 1991. A-UPPT considers necessary to form the state commission on estimation of legality of the privatization of the former state property: Industrial enterprise, agrarian sector, the land, object of premises social culture life. For real provision regulatory functions state in this question, develop and take the law «about denationalization and nationalizing»;

The protracted crisis world economy witnesses about that that west model social-economic development itself has exhausted and needs for reconstructions. So Ukraine cannot headlong copy the matrix ding out public device and must search for its way, which can become the public republic, where main role plays the state with public organ of power, mixed economy and planned economic policy. The platform her creation must be a return in state property not less 50% background sector of the economy: metallurgy, machine

building, chemical branch, transport, energy, gaining industry, other high-tech, science – and power-hungry branches production with high level of capitalization and concentrations of production power, which influence upon safety state. The second most important sector of the economy new Ukrainian state must form the public enterprises of the market type. His share can form not less 30% industrial potential of the country. These private joint-stock companies, where holder personalizes shares of the enterprise are his employees. Buying shares in such enterprise in accordance with charter, impossible, but their redistribution is found in conduct of the common meeting. The sector of the free market relations (strictly capitalist) must cover the production goods public consumption, sphere of the services, domestic trade, partly product production of the feeding, light industry, sphere of the amusements, rest, home service, with/h production. The corresponding to proportions should be follow in public health, formation and culture, including in facility of the print and TV- Radio- communication. Fundamental and, in significant measure applied science, also must be under supervision state.

The state must belong to not less 50% institutions credit-financial system (the banks, funds, insurance companies and others), their amount it is necessary vastly to shorten, conduct capitalization and association bank sphere, do her unsinkable. Let this will be 5-10 banks country-wide, but this must be such financial instrument, which will cause the respect and capable to raise the economy of the Ukraine. The depths and raw materials facility must belong to the state, but right their partial development be given public enterprise and quotient capital on concessionary to base. Finally, it is necessary all learn to pay for use the depths state, for possession license of use the depths. The State in mixed economy must be as much as it is necessary folk, but the market as much as possible without causing the damage national interest of the Ukraine. For instance, inadmissible on home markets uncontrolled liberalization trade import product, undamaging domestic commodity producer. A-UPPT considers that mixed economy most packed takes into account the national nature of the whole Ukrainian folk: provide the longing to join strong public authorities Ukraine with business natures her people.

Provide operating the system fair - and distant perspective planning social-economic development of the country through reconstruction Gosplan;

Develop and give effect United System of the order for Government account (the roll), realized through State Tender commission;

In interest of the ascent of the economy lagging behind region of the Ukraine to prepare and take the State Program of the shaping the free economic areas, in base what place the production of the national knowledge-based product, development resources-economy, high-tech, scientifically based production and is made NANO technology;

Restore the state monopoly on production alcohol product (except blame, beer and low-alcohol of the product), tobacco product, mining and production of the salt, overseas trade strategic type cheese, technology, grain and corn product (on separate pepper);

Greatly weaken, but hereinafter completely abandon to chains go-between astir goods, functioning and services from producer to user that will allow greatly reducing the level of the pricing and increase the consumer network;

Create the united system of the job rating, obtain the liquidations a slanting interindustry pricing, regional adaptation normative – legal acts on questions industrial politicians;

Develop the program of the training of the personnel (frames) and cardinal increasing level efficiency of control state sector economy and management enterprise;

Develop the united system main state standard and that on consumer goods production branch with provision for world achievements;

Revise the code of the laws about labour and labor relations, create the modern concept of the reform of the payment of the labour;

Return the priority to creation non-polluting, low-waste closed cycle production, provide efficient use secondary resource and introduction them in production durable goods;

Take the program of the development market land and premises, where provide making the united unified electronic roll, cadastre, order of the free selling the land and e restrictions, procedure of the change the target use and purposes of the lands, demarcation lands state and public property, with provision for conclusions of the state commission on estimation of legality of the privatization. The chernozem of the Ukraine must work at economy state. Use the farmlands not on purpose and their simple with tall grasses, in economic development of the country be punishably.

Occupying the land, take care of her grow agricultural production, develop economy of the region, rather than capable, boards state fine in the manner of lost advantages, on average of the annual productivity of growth cultures in region. The land, being goods, must produce the agricultural product if this does not occur from year per annum, that this paradox. The large landowner, are obliged to indemnify the financial losses a state, in connection with idle time lands arable holdings, but if unapt to pay, return the lands parcels of land state, for entering them in crop rotation of the country. All that there is on territory of the country, must bring profit, and work his might at economy state and fortification.

Thereby, understanding need balanced structured reprocessing economy of the Ukraine, as one of the most important directions construction public republic, A-UPPT considers that achievement of this purpose in condition of the connecting period, possible under efficient state participation and system regulation only. Development public enterprise and more small forms production will be based also on this. The agroindustrial complex:

From decomposition to rebirth A-UPPT comes from that that in Ukraine agrarian sector economy occupies in economically complex leading place, because this not only the most important branches production provisions, but mode of the life of the much of the population of the country. The Ukraine, possessing precious natural resource – chernozem, can pretend on leading role of the producer ecological net agricultural production in Europe not only, but also in the world. However feeble control Economy State, mockery on inhabitant of the agrarian sector and agricultures of the country, have brought the branch on edge of the ruins, the land exhausted, country, producing for the whole world of the fertilizer has a no possibility to raise her fecundity, all in country is built so that pull out the last veins and squeeze last juice. For year's independence, profitability with 40% lucrative, at the average on Ukraine, was crushed before condition, when unprofitable becomes all branches agricultural production, including formed his base: sugar, corn, stock-raising, fowling, dairy, horticulture, viticulture and truck gardening. Resolve it is enough well functioned system of preparation agro-industrial personnel (frames). The central question – about the land, is not solved. Lands reform is organized with ugly deformation caused mass impoverishment peasantry. The collective farms are deleted, but

hopes «reformer» on origin facilities west type – farming, were not justified. The rural population survives to account house natural facilities. Amongst the main reasons of the destruction agro-industrial complex A-OPPT selects following:

High level of the monopolizing market material and technical resource APC and the market of the stocking up agricultural production, led to overstatemently prices on facility and understatement them on product of the agriculture. State itself promoted the preservations of the negative processes on these market, did not conduct their demonopolization and regulation of the monopoly prices since it was interested in low cost agricultural production, bought in Government reserves. As effect, appeared disproportions tried to solve granting the multiple privileges: retirement debts before state, direct grants, budgetary and subsidized credit of the commercial banks and others that was shown no more than by inefficient use the budgetary funds.

The imperfection of the legislative basis reprocessing agrarian facilities:

Law about the land, land of the code, acts about privatization, on the one hand, with other – malicious deforming the normative acts, was due to activity clans lobby, interested in spraying facilities, complex, crushing the lands for the reason conversions them in goods and light mining agrarian oligarchicals groups;

The predatory credit policy of the banks, exorbitant high percent rates and short-term loan, absence of the favorable lending agricultural manufacturer;

Exorbitant heavy system of the taxation;

The conclusion from address on direct purpose of the significant areas of the farmlands, unjustified scale transition to growing technical cultures on the lands of the sowing fund, used under corn and vegetable growing that leads to their rash exhaustion;

The absence of the united national roll of ownership of the land and terminated land of the cadastre, providing simple and dependable system of the registration of ownership;
Complex and corrupted system of the licensing production, agricultural production, absence state standard quality on not;

The absence of the United State program reduced agro-industrial complex, increasing of the interest agricultural manufacturer and his supports.

Considering agro-industrial sector of the economy as background for most existence of the Ukraine, rebirths of her potential, ascent of the living standard of the people, A-UPPT considers immediate to conduct following:

- create state agro-industrial commission for inventory of the main fund AID, farmlands, estimation of legality their mass estranging and change the purpose;
- on base of the accepted law «about denationalization and nationalizing» realize recovering the state sector AID with creation powerful agro-industrial complex of the closed cycle;
- coming from domination principle: own the land one, her processes, enter the differentiated system of the taxation for owner lands parcel of land, from favorable

agricultural production for producers, got with processed area, before progressive - increasing for the lands, not used on purpose their owner;

- take the State Program «Rebirth Ukrainian Sowed; sown», concordant with united agricultural program EC, but taking into account particularities of the Ukraine;

- conduct the state legal expert operation of all legislative acts, concerning institute of the property to the land, excluding possibility of the ambiguous interpretation of their positions in using of ownership to different e forms;

- founding on constitutional right of each person of the Ukraine to have land parcel of land, satisfy real need of the people in lands area, coming from that share this national wealth, which formed per capita at the time of taking the law about divestment of government property lands, and for one, for that moment was shown by person of the Ukraine with requirement of the residence not less 10 years, or rightfully births, with fastening the right of the inheritance. Develop the mechanism of the transfer parcel of land in property of the people;

- provide the condition of the shaping and full-fledged operation primary and secondary land market bathed-sale, leasing, mortgages, introduction new financial instrument;

- change the system financial-credit relations for agricultural manufacturer through creation state land bank;

- provide the equal access an agricultural manufacturer to subsidy, presenting direct budgetary payments; develop the clear system of their amount and receptions, excluded opaque schemes and electoral лоббистский nature;

- on base of the program «Rebirth Ukrainian Sowed; Sown», provide state support of the real producers agricultural production. Private, through system state grant, state bulk purchase and state insurance risk subject agricultural production. Create the state agrarian insurance company. However system of the state bulk purchase must not be the basis of supports of the domestic agricultural commodity producer. State bulk purchase must be conducted on open competitive base and be limited by amount of the product necessary for operating the power structures, MCS, gathering state strategic reserve and other state necessities;

- realizing legislative, regulatory and right-ordered function, state is obliged to create the equal conditions for development agro-industrial enterprise of all property categories, herewith in every way possible encouraging public, providing parity in relations, installing united order of the pricing on agricultural product, but giving right on independent choice of production activity and realization made to product;

- install the system of the social privileges and compensation rural family by means of taking the state program of the social privileges and compensation on settle;

In program «Rebirth Ukrainian Sowed; Sown» provide directions of the reconstruction destroyed rural infrastructure and engineering, networks, provision agricultural manufacturer domestic farming machines, reconstructing the domestic basis production facilities, production for agriculture, food and processing industry, developments of the sphere of keeping, transportations and conversions agricultural production, undertaking system irrigation and improvements of the functioning, provision farming machines by mineral fertilizers;

At development state standard on agricultural production absolutely necessary to bring them in correspondence to with standard EC, simplify the mechanism of the licensing, abandon to practical persons of the using the export quotas, replaceable their export tariff

for producers agricultural production since export-import «play» prices profitable only separate commodity producer, and as a whole worsens competitiveness of the product of the domestic agricultural branches;

In system of the advancement agricultural production of the commodity producer to user follows to raise the role an interregional agrarian exchanges and traditional agricultural market, consumer and market co-operation;

The most important direction of the reconstruction agro-industrial complex must become active searching for and introducing the new alternative sources power supply production basis and home necessities sowed; sown: electric powers, reception of the gas and heats from departure agricultural production, reducing prime cost of the power systems, providing autonomy of the production cycle, vital activity villagers and decision of the ecological problems regional level;

The rebirth powerful Ukrainian agro-industrial complex cannot occur itself itself. This will do the people, specialists' agricultural production: tiller, livestock breeders, poultry farmers, vegetable growers, agronomists and representatives group of ten other professions.

The care state must become reconstruction destroyed holistic system of preparing the agricultural personnel (frames) in agrarian university, profiles institute, agrarian technical school, vocational schools.

In this connection in program «Rebirth Ukrainian Sowed; Sown» follows to provide the way of attraction youth to education agricultural profession, giving her preference and privileges at arrival in profice of the educational institutions to state account, with granting dormitory, payment raised scholarship and guaranteed granting the work on professions, possibility student to have as minimum delay or waiver of call to urgent military service, but after training, granting vein young specialist, soft credits on construction of the houses;

Priority direction of activity state in ascent agro-industrial complex of the Ukraine, remain fundamental and applied scientific studies of the agrarian academy, research institute and laboratory on realization of the perspective programs of the breeding, seed farming, horticulture, tribally deal, reconstruction and increase the fertility of the lands and others however budgetary financing follows to realize under the most perspective programs, using principle of the address financing. The thread must broader use the possibility of the functioning «under the customer». The concrete commodity producer, greatly shortenning time stage from begins studies before introduction positive result in practical person agriculture manufacture. For increasing of efficiency of the scientific studies and introduction leading biotechnological technology to conduct the reorganization of the structure of the academy of the agrarian sciences, having united unproductive her subdivisions in powerful scientific centre.

Create the state seed reserve fund;

The rebirth Ukrainian sowed; sown and creation leading agro-industrials complex impossible without recovering the system social culture mode and rural infrastructure, lifting the authority agriculture manufacturer, worthy medical provision, giving the new contents cultural-mass functioning on settle, qualitative change the look of the rural school and making the conditions of attraction in village youth.

Necessary in agricultures to unfold the complex work on state program, accommodation of the orders for Government account on guaranteed buying produced agricultural production, provide the branch an farming machines, motor fuel, fertilizers, conduct

supplying with gas and mechanization of the agricultural labour, restore and create in country irrigation systems. Do all to revive, on absolutely new high level, to account of the introduction modern technology agriculture, collect whole-year, on two - three harvests per annum, to account of the extension of the light day, making the favorable climatic conditions for plants, in universal hothouse facilities, on the basis hydroponics. Provide the agriculture energy-efficient technology, alternative and renewed source of the energy, fuel element, nanotechnologies' and nonmaterial. Settle problem of preparation highly skilled personnel (frames) for sowed; sown, return, youth prepared for rural life back, raise on due level social culture mode sowed; sown, select interest free credits for construction vein and acquisition of the technology, create mechanized complex mobile crews for work execution on land, give privileges an inhabitant sowed; sown, in every way encourage initiative in agricultures, create condition for construction by state in settle small farms courtyard, provision by home population and agricultural personnel powerful ago-industrial complex – the most important segment of the balanced economy and industrial growing. ENERGI and ECOLOGICAL SAFETY for economy any state the most important importance has an energy sector, his condition and stability. The whole stage of the connecting period condition fuel-energy complex of the Ukraine caused the extreme degree agitation society. A part change political manual, slanting in privatively politician, absence clearly outlined strategy of the development state, fight oligarchies clans for possession by access to energy resource, tough rivals on foreign markets, absence of the sources of the financing and other reasons, have brought the branch to condition, when already it is necessary to speak not about safety, but real threat energy collapse. Provide the economic ascent, increasing of well-being of the people Ukraine will not be able to provide without modernization fuel-energy complex. Cannot state to be real political independent without independence energy. That existed all last years? That and acting power and opposition power used TEK Ukraine as trump card in fight for achievement their own markets integer, as financial source of the provision of its stay on top of the public pyramid. For yesterday else powerful in energy attitude of the Ukraine, in full growing, has got up the problem her energy safety. The alarm trends exist in gas, oily and energy sector economy, in coal industry. Not before the end is formed and bad functions the energy market. The system approach is absent beside the authorities to decision of the complex problems of the energy strategy, conditioning economic and social results internal reduction country. All are her branch, profile ministry and department, committees and science act in production of the strategies and comprehensive programs is disassociated, is not consolidated. The society is in general discharged from this functioning. As a result, heavy created legislative basis of the operation and developments TEK remains not terminated, not meeting the demands time, not to the full takes into account the particularities external and internal economic factor with the result that in country exists the firm trend of the outgrow purely economic problems in political, including international level. The effect cleanly fights politely Ukraine were so named

«Gas» and «Oil» wars, unlaced her with the most main economic partner and supplier of the power systems – RF.

Except fixings to country of the economic damage this undermined image Ukraine in Europe, as transited power resource, has put (deliver)ed it on verge of the energy crisis. The new project of the energy strategy of the Ukraine before 2030, born in cabinet present authorities, does not give the conceptual vision of the achievement put (deliver)ed integer. He does not exclude the influences, so strong for Ukraine of the subjective factor, internal and external lobby does not reveal the criterion of the successful development Ukrainian TPP, it is not enough takes into account to particularities and world trends in sphere of energy independence and safety, weakly reflects the aspects of ecological safety. A-UPPT considers that work within the framework of development nation-wide strategies fuel-energy safety of the Ukraine must provide:

Development of the theory of energy safety: her conceptual base, principle of the provision, revealing the directions of the threat national interest in energy;
The analysis of the current condition and problems of the operating the branches fuel-energy complex, defining the offers on prospect of his development;
The expert operation legislative and normative acts on energy strategy and politician of the Ukraine, their development and estimation of social value;
The analysis of the achievements and world trend of the development of energy, forecasting of the most perspective directions international cooperation Ukraine;
Searching for of the ways of the diversification of the deliveries in Ukraine energy type cheese and power systems, defining e energy balance;
The analysis of the decision existing and forecasting of the possible arising the new problems of the provision nucleus and ecological safety of the Ukraine, being due to operation TPP.

Absolutely obviously that development of the project «Strategies of energy safety of the Ukraine» follows to terminate at the shortest periods with broad attraction of the public. With provision for positions already accepted document to conduct the expert operation of the laws about TPP Ukraine, economic program of energy efficiency, other normative acts, having adapted Ukrainian energy legislation with legislation EC, herewith having provided restrictive measures for foreign investor in strategic significant for national safety segment energy. Follows to define the law, what enterprises TPP must remain in full property state, but what can partly, or be completely privatized.

Coming from estimation of the most threats of energy safety in nearest prospect, A-UPPT will obtain:

Failure of the Ukraine from participation in unpromising project, initiated by government. This participation in construction oil-transit corridor «Kirkuk (the Iraq) – Trabzon (Turkey) – MNS «South» (the Ukraine);

In construction of the gas main «Nabucco»;

In construction new OTZ in Odessa and Ford;

In construction mythical gas main «White flow» and others;

Undertaking general audit National State companies «Energo-atom», «Oil-Gas Ukraine», «Energy company of the Ukraine», «UkrGas», UkrTrance Oil», Bipper and others, and their restricting.

The Ukraine on 70% depends on import of the power systems, herewith has one of most gas-intensive economy in the world, in which share of the gas forms 41%. The gas sector sloppy, depend, is absent his transparent market. Very low efficiency gas-transport systems. The pipe lines before extremity worn-out. In sector to high indebtedness and system defaults on a payment. A-UPPT sees need in decision of the following tasks in gas sector:

Adjust legislation for right warranty granting of the mining the gas for gas-exploration of the companies, remove the restrictions on trade gas, extracted in Ukraine for enterprise with 50% state capital;

Reduce the tax on mining the gas in Ukraine that will promote increase the internal mining and reduction of the share of the import;

Take the Law «About the market of the gas» and on its base to form acting on installed rule gas market, exclusive lobbying of the scheme and corruption in gas sphere, possibility of the unauthorized selection of the gas;

At system gas-transport conservation in 100% property state, for increasing of efficiency Bipper, reductions of the technological expenses and losses by reason of dilapidation pipe line, attraction investment on modernization, A-UPPT considers possible entering the Ukraine in international gas-transit consortium with participation EC and RF;

Adjust the tariff loads of the users industrial and home gas, with obligatory installation counter that of them, who consumes him from gas main;

Stimulate exploring and development new gas field in Ukraine, including on offshore areas Sea of Azov and Black Sea, giving concessions investor for mining the gas, including foreign, having cancelled assignment of quotas gas, produce in Ukraine;

Acknowledge expedient and perspective construction of the plant on dilution of the natural gas on seaside is Cream on agreement of the deliveries of the liquefied gas from Iran of the long action;

In system госкомитета on questions of the state material reserve, conduct change share spare power resource, way of the creation (not reducing coal) of the strategic reserve fund petrochemicals in volume not below 120 day;

For achievement predictability gas market A-UPPT considers necessary to sign the long-term contract with the main producer of the natural gas «Gas Prom» (for 25 years), with transparent and clear mechanism of the deliveries, formulaic of the determination of the price and mutual warranty, not allowing politicization of the subject and e use in political purpose;

When turning to market prices on gas for home necessities, the populations is obliged to get covering the costs. Define for indigent's category of the people highlighting subsidy not through «RegGas», but target method through organs of social protection;

Provide in Law «About the market of the gas» list object, which can be not unplugged from consumption, as well as mechanism of the redemption of indebtedness.

The base of energy safety of the Ukraine on long prospect will as before remain increasing of efficiency of the use own power resource. However in recent years Ukraine all confidently changes from producer and exporter of the electric power, in her buyer, all

further leaving from energy-efficient models of the economy. In recent years 90% electric powers were made on NPP (47%) and TPP (43%), and only a little more than 5% on hydroelectric station. On renewed sources happens to around 1% from the total its amount. Energy forming energy safety Ukraine not more problematic, than gas sphere:

- Low efficiency of the generation of the electric power and efficiency her use;
- Has grown old and worn-out network main and distributing line electricity transmissions, low degree of their safety;
- High level of the technological losses;
- The level tariff does not cover the production costs electric powers that brings about perverted practical person rotational unhooking;
- The market of the electric power hypertrophied and does not provide the sufficient level an investment in energy of the Ukraine;
- Is absent real suitable and sufficient reserve of the powers in power system that quite often brings the users about mass unhooking; Weakly requirements are executed on reduction bad surge and equipment TPP modern system peelings.
- Coming from that that in medium-term and distant, prospect atomic and heat energy will form the base of the energy potential of the Ukraine, A-UPPT considers necessary: cardinal to change the budgetary politician and financing the branch, debug the effective mechanism of the provision necessary level invest in energy sector;
- Develop the program of preparation to association of the power system of the Ukraine and EC;
- In functioning government to exclude the corruption practical person «manual control» NAEK «Energy-Atom» and NAK «Energy Company of the Ukraine» way of the taking the resolutions of the national commission on regulation of energy about change the algorithm of the sharing the facilities, addressing on energy market;
- Take measures on termination construction energetic blocks on NPP with safety level provision, corresponding to standard EC;
- Conduct the expert operation acting document normative and legislative basis of the provision of safety nucleus object; contribute necessary change on adaptation with ecological legislation of the Ukraine;
- Provide the most quick reconstruction of the object «Covertures'» Chernobyl NPP;
- Take the Law «About prohibition of the import, conversions and waste burial on territory of the Ukraine departure atomic industry foreign state»;
- Reorganize the state organs of the constant monitoring nucleus and ecological safety of the Ukraine, basing its activity with provision for adaptation with legislation EC;
- Prepare the state program of the reconstruction and conversion TPP. Stop, process of the diligence of the heat energy powers of the Ukraine, and liquidate the deficit a specialist and resorts of the basis;
- In technical rearmament of heat energy of the Ukraine to go to using modern technology incinerations of coal:
 - caldrons with circulating boiling layers, close-coupled firebox, caldrons with super critical parameter, gasifies of coal that will allow to reduce the expenses of the natural gas in 6 once, equip all TPP modern system gas cleaning, providing reduction bad surge;
- A-UPPT considers possible for increasing of efficiency TPP and in purpose of the modernizations this energy sector, conduct partial selective privatization. Herewith conduct the state expert operation of the privatization Ukrainian «RegEnergy». A-UPPT

considers necessary in principal to revise the attitude a state to estimation dug and place of coal industry in system of the energy balance of the Ukraine and provision her energy safety. In this connection:

- analyse efficiency and move of the performing the program «Ukrainian Coal» and take the new state program of the scale modernization of coal industry, based on principle understanding of coal industry, as bases of energy independence of the Ukraine.

For base of the program to take «Concept reduction coal branch of the Ukraine», offered MCP;

Provide and begin the immediate renovation remained state mine fund, considering this essence «Strategies of the development of coal industry» with simultaneous planned mastering new raw materials region and creation coal-concentrating factories;

Restore the domestic production of the mountain mine equipment on base the most latest technology sparsely populated coal production process in specifically dangerous term, with the most latest cleansing automated complex, knives complex for adjustment fine layer, tunneled combine for safe undertaking the productions on emissions dangerous layer, panel unit for adjustment steep layer with unstable sort and other type of the technology and technology;

Forbid unfounded closing the mines, which are a single source of life sustenance population occupied in her production, offering creation on this base of the public enterprise with granting the favorable lending and target state subsidy. As well as highlighting subsidy for gradual cessation coal output on unpromising mine.

One of the ways of the realization of the concept of energy safety of the Ukraine, A-UPPT sees in reconstruction and extension of the system hydroelectric station, their use on Small River with constant balance hydroelectric potential. These HPP real capable to settle the problem power consumption on regional level, first of all home importance. In this connection A-UPPT will pay attention realization perspective project production of the alternative energy in general dimension consumed power resource (the solar batteries, windshield of the installation, heat pumps), so as to 2020 bring their share before 15-20%. The is important for A-UPPT will be support «Concepts of the state program on development and production biological type fuel on 2010- 2015», also having greater prospect of the regional decision of the energy problem.

A-UPPT also sees necessary to develop the United State program retooling industrial production complex power efficient by equipment, because accepted law about stimulation action on energy conservation does not work in scale of the country. In him real acts only tax privilege, dispensing from payment of the duty on taken from abroad energy-efficient equipment. A-UPPT will obtain that all privileges of this law have came into play:

- were frozen from payment vat enterprises, завозящие equipment for production alternative type fuel;

- 100% privilege were provided on profit at production on territory of the Ukraine power efficient equipment, working at alternative type fuel provided that liberated facility are used on extension production.

A-UPPT considers the task of paramount importance support and introduction the latest technology production of the energy and new type fuel;

In particular with use the renewed sources. For the reason attraction of the investment facilities, to realization of the program of increasing of energy efficiency, use the renewed

sources of the energy, as well as the most latest technology, A-UPPT sees need in development and taking the state target program:

«Atomic-Hydrogen, hydrogen, alternative renewed energy and fuel elements, nanotechnology and nano-material Ukraine» and making the state national company «New Ecological and – Energy Projects»("NEEP") A-UPPT offers to examine a question participations of the Ukraine in international ecological project «Peace Hydrogen and Energy» and making the international technical consortium «New Ecological and Energy Projects», with country EC and other. The main organizers and project managers with Ukraine task international ecological project «Peace Hydrogen and Energy» – development and introduction in everyday life, and modern production new, unique developments in the field of high technology. The realization of the project «Peace Hydrogen and Energy» within the framework of consortium MTC «NEEP», at participation of the Ukraine will allow at the most short periods to get the electric power and other power systems, cost which will be in several times lower, exists today on internal and foreign markets of the countries EC and others. This will provide energy safety a state, will raise the level of living populations, will create the sound competition on the market of the power systems, will vastly reduce the cost of the generation in country, in contrast with the prices which at present offer the monopolists from energy. The state will be able to check the situation, stabilize the market and control the internal prices on power systems, but state associations EC and others countries capable to create, inwardly associations, united price market of the power systems, protect the economy of all countries from energy dependency and cutting the fluctuations of prices on power systems in the world. Within the framework of international technical consortium MTC «NEEP» is planned organization cooperation with state of the European Alliance (EC), organization Black Sea Economic Commonwealth (BSEC), Asiatic-Pacific Economic Cooperation (APEC), Country Briquette (the Brasilia, Russia, India, China), Alliance for the Mediterranean (AFM) and other international ecological, economic, scientific, production enterprise and organization, with investor and banks. The whole 79 countries, embassy and representation, 29 large international ecological organizations, expert structures in the field of energy, fund and associations, financial institutions, investor and sponsor. The international ecological project «Peace Hydrogen and Energy» and project of the making the international technical consortium «New Ecological and Energy Projects» at participation of the Ukraine will create on the first stage its economic self-sufficient home market of the countries, to account of the use the high technology. On second stage will form united external economic self-sufficient market, with participation of the economy of the countries EC, BSEC, APEC, BRIC, AFM, which will unite the population developed state planets, but this more than 4,6 billion person, on territory which will be marketed all modern projects in the field of «High Technology», program «Atomic-Hydrogen, hydrogen, alternative, renewed energy and fuel element, nanotechnology and nano-material», including on diversifications of the sources of the energy at connecting period, from hydrogen energy to hydrogen economy, when preparing each State to participation in International Ecological Project «Peace Hydrogen and Energy».

Purpose of the realization of the International Ecological Project «Peace Hydrogen and Energy» (IP «PHE») – cooperation with all state in actual and perspective direction fundamental and applied scientific studies, on priority directions of the development of the science, technologies and technology:

«Production and introduction National and Trance National of the knowledge-based product», «Energy and Energy Conservation », «Industry nano-systems and nano-materials». Dimensions and difficulty of the introduction modern production, scientifically – exploratory, technological functioning, the last world achievements specialist in the field of diversifications of the sources of the energy, atomic-hydrogen, hydrogen, alternative, renewed energy, energy conservation and nanotechnology, require the associations an effort and facilities, all countries on national and international level. A-UPPT supposes all actions on provision of energy safety of the Ukraine unhewn from decision of the problems her ecological safety. In this connection espouses undertaking the monitoring of efficiency of the action of the Laws of the Ukraine «About ecological expert operation», «About ecological network of the Ukraine», «About national ecological program of the address with nuclear waste», «About ecological audit», about transportation dangerous cargo, timber, water code and others.

A-UPPT considers necessary to take the changes to some laws about sequencing the questions of social protection of the population, living on victimization territory, in specialized zone of the observation enterprise on mining of uranium ore, nucleus installation and object, intended for referencing with nuclear waste, as well as salvaging chemical material, ammunition, missile fuel and dangerous reagent. A-UPPT considers necessary to reduce the tariffs of the payment of the electric power to population these region before 50% from full cost. A-UPPT espouses taking the Law «About protection animal world of the Ukraine». Absolutely obviously that with provision for consequence Chernobyl catastrophes, ecological situation in Ukraine was transformed in exceeding social problem, which decision requires the enormous capital investments and cooperation with world community. A-UPPT considers the ecological politician, as component part of the state strategy economic and scientifically – technical advances of the country. In industrial production – this using leading wasteless (the low-waste) technology, use renewed, ecological clean sources of the energy and ways her receptions. In agricultures – turning the husbandry on adaptive forms, use the breeding, genetic engineering, and salvaging departure. In urban planning and public facilities – development ecological clean and safe territory.

A-UPPT responses the conservation an landscape and biological variety of the Ukraine, development national park, protected territory and protected natural zones, increasing dug public, non-government organization, their participation in expert operation and supervision the condition of ecological safety, in ecological upbringing the population.

THE TRANSPORT AND RELATIONSHIP.

The communication possibilities state – the most important factor of success his economic growing. The transport provides the unity a market, intercoupling region, mobility of the people. The Ukraine is found on crossing the largest transport pathways. The transport facility for have no strategic importance. However presence of the serious problems controls for present-day day development branches:

- is not terminated by her conversion, having by main purpose partial break up the monopoly, denationalization infrastructures and rendering the services of transportation;

The branch remains extremely politicized and criminalized by sphere in fight clan for power and influence upon economy of the country;

Is it weakly used geopolitical position of the country and possibilities available communication for accretion volumes of the international transit cargo on international and intercontinental transport corridor;

The low intensity of the renovation of the main fund all without exception type transport and developments of the infrastructure;

Irreparable backlog from EC in improvement transport technology new generation, informatization of the transport process, introducing the new managerial systems;

Has grown old, is not updated park of the facilities, transport communication:

- Railway, car, aircraft, sea and river transport.

The repair transport railroad yards require reconstruction;

The quality of the transport infrastructure of national importance (the roads, bridge, station, the centre of the logistics, aerial,- sea and river port, services) does not meet the demands economic development of the country. Not to conduct the construction of the new communication network, transport uncoupling;

In sorry states be in the town transport system a majority region of the country. The special anxiety causes the condition of the public transport, which park has grown old and is not updated for many years. Aside from human factor, the reason undeterminable turns damage and catastrophes, carrying away thousand of the human lives annually, is a bad condition of the town roads;

The system of the supervision, guard and notifications on transport does not meet the demands preventions of the manifestations of the terrorist acts, term of safety of the motion and conservations of health passenger;

Tariff and price policy in system of the rendering the services to population on transport not dynamics, not transparent, economic is not motivated, allows cross backing passenger and suburban transportation to account cargo that brings about low efficiency of the sector as a whole;

On transport are very high energy expenses. The ubiquitous dictate merchant by fuel for motor transport, often not justified, speculative image replacing their own ruffled expenses on users;

The system of the sharing the facilities and motion money flow in sphere of the transport, construction and service communication extremely, Opaque, subject to dark scheme and corruptions;

Does not meet the demands and is not improved system of preparation highly skilled personnel (frames) for transport. Great their fluidity and deficit labor resource by reason of low salaries and bad terms of the labour;

The weak rate develops domestic avian- and auto industry, shipbuilding, production all type electric transport. Are not conducted up-to-the-mark scientifically – exploratory and experienced – design work on development of the transport, systems communication and relationship;

In branches very low efficiency investment politicians;

denationalization facilities, relationship and telecommunication network is organized with breaches antimonopoly legislation and state has practically forfeited regulatory function in given sphere («Ukrtelecom») that is much harmed for system of national safety state and his mobilization possibilities;

The market of the services relationship and telecommunication are disbalance and weakly functional. The populations are offered facilities of the yesterday's day under monopoly high price job rating;

The level installation of telephones, particularly rural region, remains low. Internet remains expensive and inaccessible pleasure for most of the population;

Remaining monopoly state, has not suffered the due modernization and refining «UkrMail».

Coming from importance of the transport and relationship in system economy complex of the country, A-UPPT sees its role in that to, in – first, all available way to call attention folk and government on ugly disproportions, established in given branch, in – second, using its political influence, obtain in medium-term to prospect change, promoting qualitative new development of the transport and relationship in Ukraine. Here:

- taking into consideration entering the Ukraine in WTO to conduct state monitoring the correspondence of the legislative base of the development of the transport and relationship of the Ukraine new condition, her adaptation to requirements EC and CIS;

- develop and contribute on consideration of the Supreme Soviet project new Laws: «About base of transport activity», «About national concept of the development of the transport and relationship before 2020»;

Obtain removing from sphere of the influence of all political power financial and operating – economic activity of the railways through separation of the State administration of the rail-freight traffic (Ukrzalznici) from Ministry of the transport in separate economic subject, having left for Ministry function determinations of the strategy of the development of the branch;

Acknowledging necessary realization government control for transport infrastructure, A-UPPT considers possible to realize the partial privatization her not profiled and servicing subdivisions, give a chance quotient an operator transportation to organize the sphere of the services on state infrastructure on lease or concessional to base, hereunder enlarging influx quotient capital in branch in several times to existing;

In system of the State financial monitoring or Counting Chamber to form independent from department of transports subdivision on access to transport infrastructure and issue license, quotient to companies and supervision for observance tariff politicians, standard quality and safety;

On the grounds of contributing the change and additions in Laws of the Ukraine «About transport», «About the prices and pricing», «About natural monopoly» and others, develop new tariff management, defining tariff politician and activity of the tariff commissions; Produce restructuring State administration of the rail-freight traffic, prepared infrastructure management from rendering the transport services and regulations;

Continue the renovation a parks transport facilities, modernization of the infrastructure all type transport, transshipment complex, port, terminal, navigational equipment;
Terminate making the complex basis of the informatization, introduction information technology for the reason the most quick start the united system information communication on transport and e following integration in world transport information network;

Avoid cross backing passenger transportation to account cargo. For compensation of the expenses on transportation favorable category the passenger to provide increase the budgetary funds, simplify the rules of transportation passenger;

Raise the level a construction and servicing the domestic superhighways before standard EC. For this produce the reorganization Ukrhighway, prepared functions of the customer and contractor, having selected building sector in independent structure «Ukrwaybuilt», but functions of management and servicing the roads having left for «Ukrhighway»;

Provide increase transit flow through territory of the Ukraine before 40% to account of the termination and commissioning the superhighways «Lvov – Cracovec», «Lvov – Fords», autobahns «Kiev – Vinnica – Hmel'nicki– guest border with Hungary», routes «Kiev – Harkin – Dovjanski», routes «Kiev – Smoke – Gluhov – Botches - before border with RF», roads «Lvov – Kirovograd – Znamenca»;

A-UPPT considers expedient to consider and take to realization projects «Roads Crime» within the framework of participation in international project construction autobahns around black epidemic deaths, as well as construction with RF bridge through Kerchenskii strait;

In avian transport to conduct the modernization an airport in accordance with international standard, with expansion new terminal, their transfer in concessional management at term of the conservation of the state property on take-off landing, bands and aeronautical services;

A-UPPT considers necessary to conduct state certification aircraft park all existing air companies of the Ukraine on subject of the correspondence to requirements that their usages. Reasonable conduct the liquidation small, with small number of the aerotechnics, or their merging in companies, capable to normal operation;

A-UPPT will promote the quickest development of the agreement about «Open Sky» Ukraine with EC and other country;

Reconstruction Ukrainian avian - and ship buildings A-UPPT considers the most important problem a state and all united ideas of the rebirth of the economy of the Ukraine, political power;

The development transport corridor it is impossible solve without improvement of the procedure of the passing through Ukrainian customs. A-UPPT considers necessary introducing the intellectual transport systems (ITS), shortening procedural time;

In system of the use the individual transport, A-UPPT considers necessary to contribute change to Tax Code about liberation of the categories retiree from tax on transport, as well as reinforcement ecologically supervision the transport and cargo;

In questions of the further development relationship and telecommunication A-UPPT espouses development telecommunication market Ukraine, conservation checking block of shares «Ukrtelecom» for state, for the most quick introducing the services relationship

third and fourth generation under expansion network fixed relationship, in rural region particularly, for contributing the change and additions in Law «About radio frequency resource Ukraine».

MACHINE BUILDING AND HIGH TECHNOLOGY.

Being important branch of the national economy, providing it is enough high added cost of the final product, in comparison with raw materials branch, the most quick introduction leading technology. Machine building in Ukraine today has only 13% in her industrial production, where transport machine building stands out in the best party, having share in 40% on branches only to account of the realization of the scale programs of the technical rearmament in RF. Boot machine-building enterprise at the average NPO Ukraine forms 30-50% that is defined main by problem of the branch – absence firm sales market. In many morally and technologically outdated product of Ukrainian machine building, not competitive. The wear-out of the equipment on branches reaches 60-80%. Aircraft building, engineering tools and production farming machines is found in deep, protracted crisis. Taken state programs on activity of this sector of the economy marketed on 10-20%, or not at all work.

The inadequate approach government to financing the taken programs of the ascent of machine building does not give the enterprise of the branch to plan the production and successfully realize the strategy of its development. What sees A-UPPT complex of the priority measures on achievement main purposes of the reforms in machine building?

A-UPPT considers that increase the share of the branch in economy of the country and growing volume of production today possible to reach to account of the boot the production powers not less than before 70-75%, increasing of power of the labour and scale investing in branch;

In this connection A-UPPT allows the possibility of the undertaking in machine-building branch selective, not influencing upon reduction of national safety, privatization;

All critical for national safety forming branches, must as before remain in state property, but be subjected to urgent scientifically – technical and technological rearmament. This first of all enterprises MIC;

In sector of machine building, having in prospect serious potential competitiveness (aircraft building, cosmic industry, rocket production and others) reasonable consolidate assets by way of the creation consortium with world producer when supervision on the part of state that will allow to attract new technologies and investments;

A-UPPT allows here possible and partial privatization through sale separate branch segment National Corporation;

For stimulation of the technological renovation reasonable to cancel the customs duties and give the delay on payment VAT on approved by cabinet minister list of the technological equipment for enterprise of the branches;

Through co-ordination taken state programs in the field of industrial production to create the firm home market of the product of machine building, stimulus for increasing innovative and investment activity enterprise through developed stock market;

The activity to use the possibility of the modernization of the transport infrastructure, energy and gaining industry in RF and Kazakhstan for growing volume of production enterprise of machine-building industry of the Ukraine, making the favorable political relations, not discordant rate WTO and antidumping legislation;

A-UPPT supposes that all these actions are found in feed forward from revision systems of preparing the skilled personnel (frames) for machine building and serious correction industrial politician state.

A-UPPT considers necessary on Ukraine to unfold the scale work on introducing the program of the high technology, active production and introduction national and transnational of the knowledge-based product in all branches production and in the total in the first place, heavy and chemical machine building. Conduct reequipment and technical retooling gas-transfer station, heat- atomic- hydra- power station on introducing the turbines, generator and compressor of the new generation within the framework of international ecological project «Peace Hydrogen and Energy».

THE INDUSTRIAL POLICY AND MACRO STABILITY.

Solely important factor of the economic growing in term of the connecting period and shaping the economy of the market type in Ukraine, is weighted industrial policy state, clearly defining purposes and directions of the structured realignment of industry, shaping normative-legal basis of the management, provision of competitiveness of the domestic product on internal and foreign markets. Occupying in economy of the Ukraine leading place, industrial complex today, power external and internal reasons, objective and subjective nature, outlives the trying times. Marked in the first, years XXI age positive change, growing volume of production, GDP, in the first place in black and colour metallurgy, chemical industry, machine building, light industry, woodworking and others, have altered by sawing in stage of the firm fall production. This witnesses about weak base preceding activity period of the economic development, about presence hypertrophied structured deformation in economy, about a big dependency from state of affairs in black of metallurgy, machine building, TPP and conjunctures of the foreign market, first of all state sector. In spite of preferences and privileges, provided to by government state sector economy, efficiency his remains low. The reasons this A-UPPT sees:

- In weaknesses of corporative control, where are absent the board of directors, purposes and tasks public industries opaque, short, is torn away from strategic directions of the development;
- In control enterprise exists direct interference a state, is felt lack of the experienced branch managers;
- Expression from enterprise income «at any cost», holds up their modernization, technological and innovative development, and improvement of the infrastructure.

That introduces necessary to do for increasing of efficiency public industrials?

A-UPPT supposes:

- For each branch to develop the purposes of the development, up build with their account regulatory mode, define the possibility of the partial privatization and liberalization market;
- Remove state property from control branch ministry and transfer in conduct state holding company, leaning on management methods of the commercial sector;
- develop the clear branch politician commercial and social nature; limit the influence a ministry on production process enterprise and interference in their control;

- create the board of directors, committees on audits, on strategies, on purposes, remunerations and others develop the regulations of the monitoring, create the system of preparation of management and professional composition of the production process;
- develop and legislative to confirm the position about state holding company, program of their introduction, extensions and attraction enterprise private sector.

In questions of the development and realization industrial politicians and in achievement macroeconomic stabilities A-UPPT sees its task in that that real to value the position of the deals in industry, efficiency action executive authorities in this area and define the way for economic ascent, increasing, competitiveness of the economy and growing of well-being of the people of the Ukraine. Today macroeconomic situation in Ukraine ambiguous and is characterized by instability. Falls profitability, grow debtor and creditor , including state debts, indebtedness, is untwisted wheel inflations, conditioned by growing of the prices, increase the cost of the import clinging to dollar rate, falls power of the labour, in state sector of the economy particularly. Many levers monetary politicians have lost its efficiency. Overcome this situation possible applicable effective strategy of the economic growing, which instrument is it is correct formed state industrial policy on the basis of the High Technology, purpose which – increasing of efficiency and competitiveness of Ukrainian industry on external and home markets, and transition on this base to stage of the efficient economic ascent. This defines the strategic task – provide the overtaking rate of growth of the volumes of the scientifically based product of machine building with High Technology, light and wood-working industry, as branches, with quick turn of the capital, at conservation rate of growth in base branch (metallurgical and chemical) and reduction of the energy expenses. The duty state – create necessary economic, political and social terms for provision of competitiveness of the Ukrainian economy, otherwise – realize the measures an macroeconomic nature, amongst which A-UPPT selects following: Improvement of the structure industrial production;

Introducing the High Technology in the field of «Atomic-hydrogen, hydrogen, alternative and renewed energy, fuel element, nanoindustry, nanotechnology and nanomateriality» production of the full-fledged national knowledge-based product with full cycle, from development and pilot of the installation, before introduction in industrial production shaping the full-fledged home market of the domestic product and services with united rule all his participant;

The determination of the state priority sector economy, having potential possibilities of the reception competitive preferences on world market.

For Ukraine this can be:

- In machine building – introducing the high technology in production aircraft and racket-cosmic technology, shipbuilding, energy and engineering, some production of the electronic technology and facilities, relationship; in metallurgy – introducing the high technology in production high-strength pipes, water and gas of the pipes with covering, fine car sheet, aluminum foil and spongy titanium, steel tightrope and armature;
- In chemical industry – introducing the High Technology in production of the mineral fertilizers and chemical means of protection plants, goods of the home chemistry, synthetic washing facilities, reagent, rubber product and it is difficult flaring up tapes;
- In woodworking – introducing the High Technology in production of the veneer, paperboard, special type of the paper, furniture, flake board and fibreboard, match;

- In light industry – introducing the High Technology in deepened conversion flax, raw leather, sewing and knitted production.

Support of the industrial infrastructure (transport, innovation, educational, research, social and public);

- mastering on plant MIC nomenclature of the technology, which previously was not produced in Ukraine, on technological factor not transferring foreign analogue, but with more low prime cost;

- The development of the legal basis of support of the priority directions of the rebirth of the economy and the further steady raising of the rate of production. Granting motivated tax privileges must be realized not stagnate branch of the economy, but young, having real possibilities to be in prospect competitive. The stagnate production can be given target subsidies (the mountain metallurgical complex and agrarian sector of the economy);

- Creation favorable innovative climate and development of industry information technology. Join in united national system of the account project of the development of the science and technology;

- use the technical regulation as element industrial politicians, improvement antimonopoly legislation, tightening the supervision natural monopoly and carrying the accent antimonopoly politicians on reluctance to abuses their monopoly position;

- The fortification of the financial sector of the economy, development financial market and introduction new financial instrument;

- Use politicians' state bulk purchase in interest of the development of industry in purpose of the ensuring the guaranteed demand domestic enterprise, «tightening» its product before level import analogue;

- Create the system of the state forecasting negotiation present inertial developments of the economy, searching for profitable market, prospects of the development of the supply and demand new technology.

The realization customs politicians must be directed on making the happy circumstances for domestic commodity producer and conformed in interest of the realization of the total strategy of the ascent of the national economy through differentiation charging duties on import. A-UPPT, considering in the centre of the economic development of the person of the labor, considers immediate to conduct the reform labor legislation and payment of the labor, leveling the labor relations. Ensuring the social privileges, state warranty and protection interest mercenary workman. Take the new Code about labour and payment of the labour. In mercenary form of the labour mortgaged mass usage people and development modern production collide with relations hired. A-UPPT considers possible to change the nature of the production relations through giving him public nature and increasing motivation, leading to growing of power of the labour. The best form changed production relations are a public enterprises, built on principle equal partner relations («one person – one voice»). Their fairness is expressed in that that whole income of the public enterprise is distributed between member of the labor group in accordance with amount and quality of the labour each. The unity interest defines the growing individual income workman in system proportion enterprises. It is expressed in consensus of the most significant decisions, defining strategy of the development of the enterprise, approving the system proportion, sharing the share income, hiring the administration and others, as well as in transparencies management and financial operation. Creation public self-governing

enterprise is a transition to high, in contrast with hire, the form of the production relations, leading to significant development of production power society.

A-UPPT considers also necessary to take nation-wide program of the fight with unemployment, provision of employment of the population, creation new worker places, reprocessing market of the labour, systems of the professional refresher course of the personnel (frames) and adaptation dismissed officer and contractors.

BUDGETARY AND TAX POLICY.

The economic reforms conducted in Ukraine at period acquisition her political independence, touched the sphere a finance, and, in the first queues, budgetary system, as mobilization facility main and spending state resource.

Corresponds to today requirements and call of time realized by government of the Ukraine budgetary, tax and credit policy?

Satisfies people of the Ukraine budgetary system structure, specified by Budgetary Code? Is our consolidated budget by authentic instrument of the government regulation ochno economic and social development?

This complex of the questions, analyzing which, A-UPPT sees necessary clear and clearly declare folk of the Ukraine that all these years we veins under chronic deficit and nonperformance of the budget, as financial plan state. The budgetary system of the Ukraine does not corresponding with task politicians economic growing and executes solely fiscal function. The high level of the state consumption frankly backbreaking real sector of the economy, about witnesses the index of indebtedness enterprise and organization before budget. manage to liquidate the runaround from filling the budget by means of netting, restructuring debts as way of the improvement of the financial condition subject managements and their payment with budget, cancel the deductions in some target state funds and others however much of the problems was transformed and, remaining undecided, was able to take cover in loopholes legislative contradiction. The most sharp amongst problems budgetary and tax system, A-UPPT selects following:

- Overweening differentiation region on dimensions of the tax revenues in payment on one person;
- Presence in tax system destructive factor, leading to excess in two times tax load on taxpayer for countries, to which pertains the Ukraine on factor GDP per capita.

Amongst them:

- Existence two subsystems of the taxation – standard and simplified that breaks wholeness of the tax system;
- The incomplete account background principle taxations (efficiency, stabilities, administrative simplicity and others);
- The scale runaround from payment of the taxes through immensely furcated network of the tax privileges and preferences, leading to growing of the corruptions.

The reduction fiscal efficiency direct and indirect taxes under her growing with income-tax of the people, as well as growing non-tax arrivals in budget and in GDP that witnesses about reinforcement tax press on population and premises of the financial crisis;

- influence upon process of the shaping revenue and expense parts of the budget imperfection tax legislation, political, corporative and other factor, defining ensemble purely populist market decisions, requiring determinations of the sources of the financing;

- In coordination budgetary and tax politician, longing parliamentary committee to overstatement planned factors, but government – to their understatement;
- The reduction of the tax rates at braking of the process of the extension of the tax basis, necessary for conservation stable unchangeable level budgetary arrivals;
- Unjustified state practicability forming the free economic areas with multiple privilege and preferences, more used for laundering dark capital and protection interest oligarchic of the groups;
- Distortion in approach to straightening depreciation politicians, specifying process of the sharing the advanced capital expenditures, reducing taxed part of the income;
- The actual loss by state of the supervision on rent and compensation by relations as important resource of the ensuring the economic growing;
- Inefficient control Reserve fund facility of the state budget. Draft on funds fund not on target purpose, conversion of the fund by Cabinet Minister in additional, in pass-by of the Budgetary code and laws of the Ukraine, the source of the financing the problems of the high executives state. To beginning of the financial crisis Reserve fund turned out to be empty.

The complex influence these factor under constant deficit of the budget, problems foreign economic and political nature, feeble manual government by economy, disbalanced state finance and have vented marked macroeconomic stabilization. The country all deeper sinks the financial crisis. The accumulation internal and external debts created the impossible budgetary balance.

Began rash outflow capital for border. Stopped the arrival credit resource from foreign banks. The federal reserve bank of the Ukraine began direct lending a government for ensuring the social payments. It is felt lack of the circulating assets, began the sharp fall a production, salaries and growing amount unemployed.«Clinging» to USA dollar financial system Ukraine has crushed the rate nation money, untwisting inflation process. The federal reserve bank of the Ukraine, without regard real need of the money system, has allowed the roughest errors in realization monetary politicians, led to devaluations national money.

Bank system of the Ukraine turned out to be one of the most imperfect and vulnerable, feeling unprecedented crisis of liquidity, credit resource, loss of the confidence depositor and client outflow, reduction quality asset, the level of capitalization (and without that artificially changed the mind). In zone of the dangerous turbulence have got the large banks of the Ukraine, servicing significant budgetary money facility. The legal base on protection of the rights obliges and client of the banks has not born check by time and circumstance. Has complicated become heavy financial situation low institutional independence of the federal reserve bank of the Ukraine, his having diarrhea legislative immunity. The danger default hung on Ukraine. What sees A-UPPT measures on passing crisis budgetary, credit and tax politicians of the Ukraine?

On base of the Budgetary Code to raise efficiency of the planning the budget on software-target method, intensify the organization of the internal financial checking, provide for budget all level solely treasury their performance, terminate reprocessing systems local budget;

Conduct the reorganization a managerial system by budget through contributing the changes to Budgetary Code that single holder state asset is a United State treasury of the Ukraine, including facilities of the reserve fund. Develop and contribute on consideration of the Supreme Soviet project Law «About United State Treasury»;

Develop and contribute on consideration of the Supreme Soviet new Concept bank system of the Ukraine, bank regulation, emissions, standbys, excluding opacity of bank activity, as well as project of the Law «About Federal Reserve Banks of the Ukraine», in accordance with which for him to leave the function of the servicing the budget;

For the reason shaping greatly profitable conditions of the concentration of the interstate securities (the state promissory obligations) and attraction of the financial facilities in economy of the country to create in Ukraine International Unlimited Bank for work with interstate promissory obligations;

For ensuring the checking the trade turnover in country, the preventions of the undermining and destabilization of the economy of the Ukraine, at connecting period, exceptions of the possibility of the destruction budgetary politicians country over profit, on essential goods, removing the capital from dark turn, ensuring the transparency of the financial relations managing subject, carry in address, New United Tax additional from producer, owner goods, work and services to their final consumer with introduction to country «fixed corridor of profitability». Thereby, will possible establish order in economy of the Ukraine, check prime cost of the product on all stage production, from mining cheese before issue of the finished products, know the trade turnover in country, qualitative to provide the collection of the taxes in budget;

On program passing financial crisis to conduct national audit the banks of the Ukraine and offer the measures upon their readjustment, conversion through merging and absorption, as well as possible nationalizing some of them;

A-UPPT considers necessary to create in Ukraine united, internal economic self-sufficient market state on the basis «High Technology» and presented International Ecological Project «Peace Hydrogen and Energy».

A-UPPT considers necessary to create the united external economic self-sufficient a common market with participation initiator Project with Ukraine and economy of all countries: EC, BSEC, APEC, B.R.I.C., AFM, including participant of the project «Peace Hydrogen and Energy».

A-UPPT considers necessary, at period of the crisis, for leaving from it, create the united economic space in the field of introduction «High Technology», program «Atomic-hydrogen, hydrogen, alternative, renewed energy and fuel elements, nanotechnology and nonmaterial». Including on diversifications of the sources of the energy in Transnational project with participation of the economy of all countries EC, BSEC, APEC, B.R.I.C., AFM (79 countries of the world), on the basis of the International Technical Consortium «New Ecological and Energy Projects» and International Research Centre of the High Technology «New Ecological and Energy Projects».

Resolutely reduce the share of the state consumption in structure GDP, reduce the tax pressure by entering the rate 13% tax. Raise securities payer of the taxes in country, greatly simplify the procedure of the taxation;

Provide the most quick taking the United tax code, integrating disembodied normative acts tax legislation, avoiding existing inconsistent and ambiguous his rates. In code clear

prescribe the right a taxpayer and tax organ, tax rates in a part VAT to draw near to rate EC. The united tax code will allow reducing the corrupt field and perfect tax management; A-UPPT considers necessary that value added tax, must answer the economic essence and practicability, as market instrument, its destination and promote the development of the economy state, rather than be an instrument for robbery of Ukrainian folk and undermining of the economy.

Solve principle the question and change always problem-solving VAT - on tax with sale, in economy of the Ukraine. Today VAT and depreciation charge necessary to direct on development and recovering the facilities, production, undertaking in country of the speed amortization. But budget of the country must, pervaded to account of the increase internal Gross Domestic Production (GDP), and lifting the state sector of the economy. The objects of the main sector of the economy of the Ukraine, which influence upon questions of safety of the country, must return under jurisdiction state, through consideration in judicial order and decisions on a matter about legality of the privatization object state and public property of the country.

Bring investment forming state and local budget before level not less 3-4% GDP;

For the reason realization co-ordinated politicians of the checking on inflation process, perfect using existing and introduction new instrument fiscal and monetary politicians.

In this part:

Provide get fat institutional independence to Federal Reserve Bank for full-fledged use instrument monetary politicians and ensuring the stability of the prices;

Enter the floating rate national money within fixed corridor;

Provide using the more efficient regulation aggressive consumer lending risk by bank sector;

Develop the actions a government on gradual reduction of the budgetary deficit and relative volumes not investment state expenses in proportions to GDP.

Introduce monitoring and efficient control of the total volume and quality of the briefcase of the consumer loans and his influence upon increase disbalance supply and demand;

Obtain increase GDP, power of the labour to account of the introducing the High Technology and provide, overtaking rate of growth of the salary in country;

Take urgent measures on modernizations market capital, improve their infrastructure, perfect the regulation and control, accessibility and choice financial instrument when provision of protection of the rights investor. Avoid the restrictions for investment instrument through liberalization rates of the obligatory instrumental diversification of the briefcases of the investment fund;

For consolidation trade platform and depositories actively to go to electronic form of the securities and legislative to define the role site depository, keeping count all securities;

Raise the activity stock market by introduction new his participant, including foreign, harmonizing license and report of the requirement with the international standard, liberalization of the rules of the moving the capital;

Develop and provide taking the Law «About join-stock companies», constantly his improve and develop within the framework of world trend. For reinforcement of efficiency stock market and quality of the control to create the united state organ;

Realize the emission state exchange bond for accommodation them in Ukrainian banks as facility of the refunding of the exchange debts Ukrainian subject managements;

For increasing of financial independence of the local home rules to account of the hostless sources of the income, and increasing of efficiency of property control, enter the property tax and regularize the system of the account owner of premises. Develop the concept and entering the united social tax, and transfer function administration united collector.

A-UPPT considers possible and will obtain the waivers of taxations of the small business with volume of the annual turn not more than 15 thousand national money and income of the people, in condition of the reduction export-import operation, necessary urgently, change in economy of the country value added tax on tax with sale;

Temporarily dispense from taxations part arrived physical persons, who use her on payment of the training, reconstruction of health, construction vein;

A-UPPT will obtain increasing minimum level income of the physical persons that are not taxed tax.

FORMATION AND SCIENCES Reconstruction society, overcoming its stagnations, economic and social rebirth don't has a prospects if it does not lean on high level of the forming the people and powerful layer of the modern science, defining innovative abilities of the nation, her knowledge-based – moral potential. Formation and science define competitiveness of the Ukraine, become the main productive direction of the national development and condition her further prospect.

The a great deal in Post Soviet period in sphere of the formation is already made. The Ukraine has defined the landmarks of the entering in European educational space. But changes to the world dictate the new purposes and tasks in sphere of the formation and scientific activity. They need for modernizations, in reorientations with traditional «academism» on real necessities society.

However perspective model of the educational system and sciences future in Ukraine as well as is not found. Are not created economic, social – political and organizing bases of the shaping state politicians' developments of the formation and sciences, their legislative provision. Under significant growing of the interests of the people in reception of the formation all keenly is marked discrepancy of the legislative basis of his provision. The Law «About formation» on conceptual rate as well as did not turn round in legislative central to each of level of the formation, except Law «About high formation». Today directly affect the interest educational institutions of the group of ten of the laws and normative acts, containing ensemble of the problems and contradiction, amongst which:

- Imperfection of the procedure of the licensing of the educational institutions;
- Some rates of the Law «About formation», having leading nature, as well as not marketed on present time. Many educational institutions have a no status of the juridical person, is not designed state standards of the financing, is not created independent state attestative service, are not provided national budget financial warranties of priority of the formation, is not designed national doctrine of the development of the formation;
- Remains low practical efficiency of the row of the rates of the legislative acts about formation. This pertains to state warranty of the people in the field of formation, about formation system control;
- The clear mechanisms of responsibility are absent in educational right for nonperformance of the laws about formation. Process of the legislative basis itself it is not enough is systematized. The Law «About formation» was formed without presence confirmed state strategy of the development of the formation that does not give the most educational rule; govern clear landmark.

With provision for dug experience A-UPPT sees the following directions of the shaping the legal basis of the formation:

a) Development and taking the educational code of the Ukraine, or the other normative act of the similar contents;

b) Consequent expansion legislative basis with provision for new requirements with the following development of the educational code. Herewith, the second direction A-UPPT considers the most acceptable, realized in two stages:

The first predestines creation during 3-5 years of the full legislative basis, consisting of separate, but systematized laws. Moreover, organs legislative and executive authorities must work out scheme «filling» base legislation on following gradation:

Background or multifunctional laws;

The organizing laws, adjusting principle questions of the educational process;

Level or branch laws, adjusting particularities of the legal relations each level formation;

The social laws directed on protection educational process participant;

The special laws, adjusting row special legal relationship. Base or multifunctional law follows to consider, requiring in update and additions, law of the Ukraine «About formation». Urgent for system of the formation A-UPPT considers the development the most complex organizing bill. To their count; calculate; list follows to refer such bills, as «About state program «formation», «About state educational standard of the main total formation», «About state qualification of the educational institutions», «About state standard of the financing the educational institutions» and in count; calculate; list branch others or level bill, development which A-UPPT sees necessary, follows to refer the bills: «About preschool education», «About the total formation», «Initial vocational trainings», «About additional formation», «About magistracy» and others in count; calculate; list social laws A-UPPT considers necessary to develop such bills, as: «About status of the pedagogical workman and his state social warranty», «About state support training» and others in group specialized bill about formation, A-UPPT considers expedient and necessary to develop following: «About educational of the functions of the formation», «About guard of health participant educational process», «About non-government sector of the system of the formation» and others for making the favorable financial conditions of the operating the system of the formation A-UPPT supposes paramount important to reflect priority importance of the formation in lives society in Budgetary and Tax code, adjusting budgetary and tax relations. The profile committee on formation and science of the Supreme Soviet to conduct monitoring the laws, which, adjusting legal relations in different field of activity society, poach on legal relations in the field of formation for the reason use the potential of the system of the formation, excluded lobbying interest of the separate branches or category of the people.

In principal important, on our vision, must become Deepening the National doctrine of the development of the forming the Ukraine. This is so important document, so great his price and role that even the slightest errors in him, is affected the interest whole state and people. In this connection follows to conduct monitoring her realization after taking for years and contribute necessary change. The doctrine must define not only strategy of the development of the domestic formation, but also display the background rates educational legislation:

Priority of the development of the formation, statehood, accessibility, continuity, scientific nature, spirituality, nationality;

The conservation unity educational space of the Ukraine and his adaptation to educational world space and EC;

The principle of the extension state warranty on realization of the right of the people on formation, possibility of the introduction obligatory 12-year formation, but in the future *общедоступность* and free of charge high vocational training.

The phased growing of the volumes of the budgetary financing the formation;

The adduction of the material position, social status and prestige teacher in accordance with entrusted task on them;

The prevention of the destruction acting network national and regional educational institutions, including way of their privatization, transfers on lower-level level budget;

Provide phased increasing of the salary workman spheres of the formation and extension of the system social warranty;

Ensuring the principle of the equal interest in result of the formation, both state, and people;

Ensuring the intensive development fundamental and applied scientific studies in system of the high vocational training;

Increasing of responsibility state for educational level of the people.

The Realization of the National Doctrine must occupy the priority place in legislative system of the formation, with provision for experience EC, but not his headlong copying.

A-UPPT espouses the conservation justified itself national tradition of the formation, against unfounded acceptance principle and methodology Bolonskogo process. From European model of the formation follows to take only that progressive that is inserted and complements the domestic system of the formation, helps adaptation with model EC. The obtruded high school credit-module system in condition of the Ukraine not efficient and needs for reconstructions. The top of the shaping the legislative basis of the formation A-UPPT considers the development and taking the educational code by way of the codification of the national laws, in one or another degree realizing legal regulation in the field of formation. Though, as a whole, way of the modernization of the educational process in Ukraine, oriented on pan-European model, answers her cardinal principles, remain the undecided ensemble of the problems. First of all, level quality formation, not satisfying market of the labour, system standard on educational-qualification level and profile of preparation, reformation of the scholastic programs, contents of the education, organization of the scholastic process, system of his checking. The low level of the student home rule, condition of the residence in student dormitory does not improve, or improve small. Manual many high schools will unground deliver the premises in lease commercial structure. Dominates the independent job placement a graduate. Falls the amount of the interested persons be trained profession of the production direction, at conservation of the longing majority student to such type of activity, as state service, financial sphere, operations with premises, trade that witnesses about low motivation professional-technical education and preparation specialist technical profile. The Law «About the total secondary educations» needs for revising. The quality initial and secondary education, in rural school particularly, does not meet the demands time. Many schools have weakened scholastic-material basis, not computerized, do not provide safety of health and safety learners. Legislation of the Ukraine does not provide the equality in rights pupil quotient and state educational institutions, does not guarantee the constitutional right of the people be trained on own language. All-out Ukrainian scholastic - an educational process, mass remittance

of the Russian-language schools in Ukraine-tongue does not promote the uniting an ethnology Ukraine and creation polytechnics Ukrainian nation. The factor of incompleteness of the reforms of the domestic formation and imperfection of his structure is an absolute absence of the educational institutions of the Ukraine in international rating. A-UPPT sees the main reason of the whole complex of the problems of the Ukrainian educational process in that that formation, either as science, not yet become priority state. Accumulated by former generations scientific potential continues to decay. His reorganization does not touch the essences of the problem, presents the mechanical process of the maintenance to agonize systems, without determination integer and construction perspective model of the Ukrainian science future, bring only to meaningless wasting public resource. Beside government today no clear vision of the structure of the Ukrainian science and managerial system to her in the manner of legislative provision research politicians.

It is necessary separate applied and fundamental science that to understand under reduction, the whole sciences or only National Academy, and as this matches up with conversion society?

Whether to headlong reject the traditions of our science in please west system?

A-UPPT considers that present reorganization of the science in Ukraine is sabotaged officer by system, including 20 management structures, basically the budgetary financing occupied by sharing the scientific sphere. In this part A-UPPT supports the opinion a scientist about entering the academic home rule instead of civilian-administrative device. The fundamental studies must as before have a state financing, but scientific budget to distribute the corresponding to structure of the academy of the sciences.

The applied science, closely connected with industrial production, must earn on its development itself, get grants on target studies from the customer, financing directly scientist, realization his ideas that raises the motivation of the development of the science as a whole. A-UPPT considers the possible part a thread to unite with public industries by creation scientifically-production concern on experience SPC «Science». The production must push the science on new quest of the High Technology onward, finance the science, give and place the orders on mastering new technology. Other directions of the modernization of the domestic science A-UPPT sees:

- Association disembodied, not it is enough functional branch thread research institute (RI) in large academic scientific canters;
- In rapprochement of the academic science with university that will enable vastly to raise the level of preparing the scientific personnel (frames);
- In increasing dug the public academy, being experimental platform in formation and development scientifically-educational module of the new type, innovation by model of the unceasing formation;
- In making the academic information bank, the broad free access to electronic journal, search system of the scientific literature on base of the cardinal system modernization of the institute research and economic information, forming the state scientific fund.

Redesign sciences in condition of the information vacuum futile.

In principle change the system of the qualification and re-attestation of the personnel (frames), increasing dug the scientist an advice. In making the state independent organ of the scientific expert operation, capable to change moral atmosphere in science and create

such forms of the organization and checking to reduce to minimum her bureaucratize and corrupt, provide protection of the knowledge-based property;

Stop the perverted practical person to Finance the National Academy of the Sciences of the Ukraine (NASU) to account of the budgetary funds of the country, but direct these facility on development of the High Technology in thread of the Ukraine. The role NASU today reduced to distribution state, budgetary funds got to public body.

Stop the perverted practical person to spend the budgetary money a taxpayer on payment of the life salary for rank «Academician NASU», since moment of his reception. This error and perverted practical person economy Ukraine and NASU has inherited and has adopted with times Stalin I.V. The similar practical persons no in the world, got in youth rank «Academician» and having stopped to concern with scientific functioning, he whole life gets the public money not imported its contributions to development of the country, sciences, fundamental and applied studies. If science in Ukraine does not develop then for that we pay the money. But if develops, that where economic effect in real sector of the economy from their activity. The Academician NASU, for their own works must get the single compensation and annually confirm its labour and new opening in science, its high rank Academician NASU. In Ukraine composition scientist, in all area and sphere of the science must rejuvenate. The system definitively ossified and not efficient in modern condition. The senior generation scientist to not to let the youth onward, on their own place and official salaries, restrain their formation as scientist, but accordingly development of the science in Ukraine. The young scientist today beck and call, indulge «husbands of the science». The youth by well-mannered senior generation and contemporaneity, does occasionally openings in science, but there as, not strange prefix itself «husbands of the science», which «Academicians» and a great deal already do not understand, long ago passed and have left from science, but science from itself do not release, as valise without handle and carry gravely and throw miserable, but on worked out year to habit, continue to use the public good.

In development of the new Law «About science and scientific activity», all-round motivated concepts of reprocessing science, Law «About base state research politicians», scientific ensuring the state programs, shaping the new paradigm of the scientific development, providing structuring mechanism of state control science;

In rebirth relationship sciences and enlightenments, because condition of the science cannot be independent from condition society. In increasing of the authority scientist, the making the conditions of priority of their functioning in Ukraine before enticing wits by west.

A-UPPT - considers necessary to create in Ukraine international Institute High Technology «Hydrogen, alternative and renewed sources of the energy» within the framework of International Ecological Project «Peace Hydrogen and Energy» (IEP «PHE») and making the International Technical Consortium « New Ecological and Energy Projects» (ITC «NEEP»).

A-UPPT - considers necessary to create in Ukraine, design - a design agency (DDA), International Institute «Hydrogen, Alternative and Renewed Sources of the Energy» (the II «HA and RSE»), which will develop, and introduce, national and transcontinental intellectual product. Master new unique, ecological clean technologies on diversifications of the sources of the energy, and bring them from pilot before industrial installation, systems of the equipment and unit for construction universal production ecology-energy complex, special platforms and enterprise on conversion borax carbons, mould board, pulps, hydrogen sulfide and mining useful fossilized in Black Sea.

A-UPPT - considers necessary to create in Ukraine, Design - a Design Agency (DDA), International Institute «Hydrogen, Alternative and Renewed Sources of the Energy» (the II «HA and RSE»), which will develop, and introduce, national and transcontinental knowledge-based product. Master new unique, ecological clean technologies on diversifications of the sources of the one A-UPPT - considers necessary, available in Ukraine world developments in the field of «High Technology» realize, in structure design-design agency (DDA), institute II «NA and RSE, which will bring the country and partner participating in project to mastering the qualitative new sources world energy resource.

A-UPPT - considers necessary to create in Ukraine small international academy sciences «Element of the world», on work with young generation, searching for of the public talents, child prodigy, smart chap and clever persons on territory all state participant of the project (79 countries) preparing the personnel(frames), future specialist and perspective employee in the field of High Technology. Education, education and preparation children, youth and youth to work on fundamental and applied scientific studies in science. Rendering financial help in education and preparing the young talents, purpose

scholarship, grand, encouraging bonus. Undertaking contest, seminar and conference on actual subjects of the scientific studies.

A-UPPT - considers necessary to conduct the auditing of the whole educational system, liquidate the scholastic high schools, not having powerful scholastic base of preparing the personnel (frames), and develop the university system of the formation. Develop and create the multisectoral and diversified high schools on the base of the Ukrainian scholastic national institutions with world name, deprive the license all scholastic high schools having perverted reputation and disgracing educational system of the country, unapt to prepare the highly skilled international personnel (frames), conduct re-attestation teaching composition and on their base to create the branches leading high school of the country. Prepare the international personnel (frames) and give the international diplomas about high formation in educational system of the Ukraine, for this conduct corresponding to certification high school, teaching composition of the country, Accreditation University in distant foreign countries. Leave in country before 50 educational institutions with furcated by network branch, affiliated structures of the educational institutions in region, but this must be such institutions that they caused pride not only beside us, but also sounded their name all over the world.

SPIRITUALITY AND CULTURE SPHERE.

Spirituality and cultures A-UPPT considers as system of moral valuables, dug folk of the Ukraine for centuries-old her history. Today system of moral valuables of our folk of the subject to most cruel erosion and decomposition.

Humanitarian, the policies transact present power uncared-for. Definitely country oriented under slogan «National rebirth», to west system of valuables and leads to ruins our spirituality, consciousnesses, cultures, based on Slavonic tradition, leads to schism society on national, language and confessional sign. System, mad draw in «European house» Ukraine's, in etc. Frank intrusion folk alien ideological models at connecting period of the formation independent state, have brought about disastrous fall of the morals in society, growing of the nationalism, extremism, manifestations of the fascism, decays of folk and young generation, especially, penetration in her consciousness of the cult of the lucre, criminal heroics, violence and cruelty. The effect moral degradation society is a penetration in school programs of the propaganda of the Nazi ideology, spreading the pornography, homosexuality, prostitutions, drug addictions, baby criminality, and drunkenness. Lead opening expansion of the foreign sects, destroying national traditions, historically created on Ukraine for the last hundreds of the years. Espousing utmost development of the Ukrainian language power, herewith, encourages the restriction, displacing and suppression, one of the languages of the international contact with population 1/6 land of the planet, including language of fraternal Russian folk – the most largest ethnic of a part of the country, breaking constitutional right of the people of the Ukraine, be trained and talk on own language and develop its, historically created national culture. A-UPPT considers its right, debt and duty not simply to call attention society on danger established in humanitarian sphere trend. We are intending to lead the resolute fight with their manifestations, influence all democratic, way on power to force her to change the hypertrophic approaches in sphere spirituality and cultures. We raise an objection to falsification of the histories; humiliations dug any ethnology Ukraine, making

part Ukrainian society. In public republic spirituality and culture must be in the field of person of state attention. In this connection A-UPPT considers necessary to contribute the corresponding to changes to constitution of the country, legislative acts about culture, about reinforcement of responsibility for manifestations of the chauvinism, nationalism, Zionism, anti-Semitism, national - an extremism, racism, fascism and religious intolerance. Contribute and take the additions to penal code of the Ukraine. Understanding that humanitarian policy of the public republic must not uncouple, but unite folk of the Ukraine, A-UPPT will lead broad explanatory functioning amongst people, initiate and obtain undertaking the referendum about giving Russian language status second state. Espousing political level of culture, A-UPPT calls all figures of the humanitarian sphere, emerge the united front to stop degradation public moral and moralities, prevent the spiritual ruin of the nation. We consider the obligatory development, as one of priority, program of the spiritual rebirth society, making the state commission on questions of the moralities and morals. A-UPPT declaimed for creation of broad state support of the development of the culture on settle, libraries, muse, theatre, cultural-educational institutions, professional creative group, public and baby creative activity. Together with that, consider inadmissible vulgarization mass culture. A-UPPT will obtain making the equal conditions and possibilities for development of all national cultures, forming united spiritual sphere society, promote their mutual enrichment in a milieu of:

Not in a complicated way understand:

- not parsed in that, what state to build, formed power and her encirclement have well understood, what rob folk and become the billionaire to his account.

Occupying itself, tearing for the further redistribution of the property power, not capable to use the found liberty in good of folk, reconstruct the society and provide the declaimed constitution a right people on worthy life, single possibility feed state mechanism, sees in abbreviation social programs. Expressing disparaging handout in the manner of cheap set

of the products, boundless promises, care about good of folk, she all deeper start the hands, in already threadbare before holes, pockets of the people.

That they have left folk?

The unemployment, poverty, disease, half-starved existence, hopelessness and awe for tomorrow's day. The power has depreciated and has frozen the savings toiling, having put (deliver)ed country on verge of the social blast. Then in Ukraine there is all for real ensuring the right of folk on labour, increasing of the living standard, free formation and medical service, moderate public and transport tariffs, worthy salaries, pensions and social allowances, not limited by kg. buckwheat and piece of bread living wage, possibility to have a comfortable home, dispose the facility on rest and each on a great deal that includes the notion social oriented state.

As obtain whole this?

A-UPPT considers that Ukraine turned out to be beside that line, when are required not half measures or that else worse, visibility of the reforms, but scolded a reconstruction society. First of all, change authorities, proclamation of the public republic and revising of the constitution.

This main!

Only after determinations public authorities, return folk unlawfully deprived to property, undertaking partial denationalization and nationalizing vitally important sector of the economy, will appear the possibility to provide acceptance and realization social oriented programs. While that polarization society deepens. The most poor her part falls into inconvertible dependency from hopeless image and way of the life. The much of the population has fallen into social degradation, leading to loss of viability. Else several years of such position in country will bring about loss integer generations of the young people, turned out to be in narcotic west and on 50% HIV – with infect. The amount of the diseases by tuberculosis in Ukraine for 10 years increased in more than 2 times.

The vagrancy, poverty and begging children have exceeded the level of the postwar years and became the national catastrophe. On level of the prostitutions Ukraine occupies 2 places in Europe, after Moldavia, life expectancy fell for 10 years, level of the costs on medicine fell below 3% from GDP, having rejected our country from leader on expenses in calculation on one person on 111 place in the world. All this effect of the most deep crisis of the social sphere, absences of the holistic concept social politicians, concrete landmark on long prospect, sidebar of the model social state.

Today all more obvious becomes need for revision integer and priority economic and social politicians, determinations sequences of their realization, correcting the mechanism of the government regulation social-labor relations with provision for specifics of the transformations state and his economic adjusting function. the main task social state A-UPPT sees in ensuring the stabilities and social protection of the people, correspondence to his politicians interest of all social layers and groups society, making the conditions for reproducing the labour, capable to provide creation such material base, when on social purposes will possible spend not less 30% GDP. Poverty and unemployment – the most important negative companion (satellite)s of market economies. For efficient fight with them A-UPPT considers necessary with provision for world experience, do the right choice of the model of social protection and on her base to develop all social programs and legislative acts. The offered ministry of the labour and social politicians of the Ukraine system Beveridga, where main task state – protection indigent people, turned out to be the

ineffective since weakly took into account to particularities and specifics of the Ukraine, not having financial possibilities for warranty to people of the minimum sufficient income. At amount of the population of the Ukraine with income below line of poverty, reaching today 40%, her reduction and liquidation turn out to be unfulfilled. A-UPPT considers that realization state politicians in social sphere must be realized parallel and in close relation with measure on rebirth of efficiency of the economy, growing of power and payment of the labour, increase of employment of the population and amount worker places. In this connection we see necessary, use financial and legal instruments on legalizations of the dark economy, prevention flight of capital, reduction of the privileges on tax, increasing of responsibility and solidarity quotient sector, attraction in economy of the Ukraine rantie-capital their offshore zones. A-UPPT considers necessary to change the methods of the payment of the living wage of the population, build her with provision for not only expenses on feeding, but also necessary facilities on home, treatment, cloth, rest, transport, education and contents children. From this must be removed and level of the minimum salary, forming not less 140-150% from living wage. The reinforcement dug the state in regulation of the social processes A-UPPT sees in that to:

Make the most potential of the able-bodied people with simultaneous their possibility to have a worthy payment of the labour.

Increasing of the share of the alive labour in prime cost of the product before 35% will vastly raise the payment of the labour and filling the pension fund;

Increase investment facilities, in person, in his health, formation, preparation and refresher course of the personnel (frames), creation worker places;

Consolidate the warranties social proofness for people, not having possibility to support its unassisted vital activity a state.

With provision for these conditions must be revised and is built legislation, adjusting process of the realization state social politicians.

A-UPPT considers the pension reform not terminated, but e normative acts, not taking into account current change. In this connection A-UPPT considers necessary:

Form the state roll provided to people of the Ukraine of the privileges and nominal account of the persons, getting these social privileges. Develop the program for identical change the privileges on money payments at the option of the people, exploited privelege;

Give effect three-level principle of the system, pension payments:

United, накопительной and voluntary pension insurance;

Free the working retiree from all type of the taxes;

Render state support an association retiree and created on their base credit alliance;

Legislative to forbid the illegal practical person of the banks and insurance companies to delay under some pretext return deposit contribution and insurance dues retiree or enforcement them to extension of the duration deposit or insurance agreements, having provided for violators of the legal rights depositor criminal liability;

Realize not episodic, but obligatory annual subscribing pension on condition on 1 January of the current year;

Provide state support health resort institutions, organization for treatment and improve one's health for invalid;

The problem of the public health conducts in social politician A-UPPT special place. This is a national priority. But public health is today found in deep crisis and needs for system reform. The Ukraine, having most amounts of the medical institutions in Europe, been out

of on the last place on life expectancy of the people. Inefficient use the budgetary funds, low quality of the medical services, their inaccessibility of the much of the population, outdated equipment, methods of the treatment and diagnostic technologies, bribery and corruption medical staff, his having diarrhea training, high death-rate sick, including children, absence medical preparation, deleted domestic pharmacopeia, on incense breathing ambulance – here is not full feature of the present public health of the Ukraine.

Are these recipes his reprocessing?

A-UPPT considers and will obtain from the authorities of the absolute execution 49 article Constitutions of the Ukraine, declaring medicine in Ukraine free and available whole folk. This signifies:

Medical branch must on 90% return in bosom state, first of all medical, diagnostic and institutions of the rehabilitation, including sanitarium and rest home;

The domestic pharmacopeia is reborn. The medicine must be available all category of the people and on its medical characteristic not to yield or exceed the foreign analogues. Arrived importer medicinal preparation must not exceed 25% (today they not seldom get to 300%). the retirees domestic medicine must get gratis, but import discounted in 30%, compensated drugstore by state.

The reformed system of preparing the medical personnel (frames), increasing of their qualification and calibrated, adapted to standard EC;

Escalated checking for use the budgetary funds, преодолена practice bribery patient and corruption medical official;

Is incorporated system of the obligatory state medical insurance, annual mass medical examination of the population and preventive maintenances of the disease;

It is organized general state inventory medical – diagnostic and sanitary fund, on the grounds of what is designed program «Health of the Nation», in which is provided:

Modernization of the available hospitals, polyclinics, diagnostic centre, points «ambulance» central and regional importance;

The restored system of the baby medical institutions, clinics full-grown and child, puerperal houses, consultation points, the centre of the blood transfusion;

It is created network of rural medicine and obstetric points, hospice and houses aged, is settled problem their material provision and safety;

Modern exploratory institutions of the direct subservience MHN are created on the basis former thread public heaths;

It is supported, with granting preferences, enterprises, organizations and public funds, rendering charitable help medical and baby institutions, taking part in recovery schoolboy, in action «Anti- AIDS disease» and others;

The reborn system baby athletic-sanitary camps;

The increased social status medical workman revised their tariff rates of the base salaries with provision for factor and addition systems, as well as granting additional furlough;

The revised principles of the financing the system of the public health, level of the budgetary financing complete before 5-7% GDP;

Nation-wide discussion project reforms of the public health are organized with participation of the broad medical public, public bodies and all interested people.

A-UPPT considers that social policy state must be oriented in future, but future country – youth, nearly one third of the population of the country. Protection her interest and balance request – essence youth politicians. This expects ensuring the even chances of the young people on formation, functioning, home, support of the family, choice and realization interest. The equality of the possibilities will help the young people to be realized in society, reveal its potential, including in political activity, control, and science and production sphere. But youth also lumpy, either as all our society. Here and learners, and students, working young people and beginning businessmen's, townsfolk and peasant, athletes and scientific employees, public-political activists and people apolitical. Consequently, and problems beside youth miscellaneous.

Who today presents her interests?

Under, that a most active part society, her most often consider only as electoral resource. The proclaimed Declaration «About the total base state youth politicians in Ukraine», beside legislative acts, state target social program «Youth of the Ukraine», state youth policy is realized weakly, is torn away from concrete problems youth. The Ministry on deals of the families, youth and sport performs the functions of the statistical organ, but state institute of the development of the family and youth under him, in compiler of the reports, report and presented by manual ministry on listening in Cabinet Minister and in Supreme Soviets. There is else National advice on questions youth politicians at President of the Ukraine, committee of the Supreme Soviet, State social service for family, children and youth, State Fund of the assistance youth housing construction at Cabinet Minister and else ensemble any greater and small commissions, as if undoubtedly existing for consumed budgetary funds. From nearly two hundred taken programs and project youth organization real were executed two-three groups of ten, but reports there is on all.

On is today accepted over 700 laws of the Ukraine and close 800 subordinate normative-legal acts, in one or another measure oriented on decision of the youth problems. Became their less?

No!

So can we consider the declarations by efficient youth policy? Can successfully work 132 All-Ukrainian to youth organizations, under opaque system of state support, ostensibly embodied in United Ukrainian Youth Forum? Amongst destructive factor youth politicians and youth motion A-UPPT selects following:

The absence pervaded sense and prospect of the strategy of the development of the youth process;

Many organizations youth, alliances, federations, associations and others, exist formally, in interest of the separate groups and are not connected with youth auditorium;

The organs of the student home rule do not fall under format youth organization, work local. Have not uniting All-Ukrainian of the organ, independence, being appurtenance administration high school and conductor of their opinion;

The student youth, learning average educational institutions are as before deprived leveled to minimum salary scholarship. The system corruption lasts in educational institutions and bribery, violating right of the young people of the Ukraine;

Not serious normative documents are designed on questions of the operation student dormitory, which administration uses in purpose of the personal lucre;

It needs the state fund of the assistance youth housing construction for revising strategy functioning (working);

Deforming the social structure youth with increase the share of the apathetic part of the young people create the premises for manipulation their consciousness;
The problems youth are considered local, in take-off from public-political processes in society. Orientating on the total social value, youth does not hope to be heard and loses the faith in state;
The established system of the higher education today does not be up to quality market of the labour, and state does not provide the graduate of the educational institutions warranty first worker of the place;
The working youth has no state warranty when sacking;
Is absent the special program of the personal education and adaptation in public-active life of the young people with limited physical possibility.

A-UPPT considers necessary for making the system of real all-round support and developments of the civil activity youth, her self-determinations and self-actualization, provision legal, humanitarian, economic premises and granting social formation warranty, improve the legislative basis of the Ukraine on questions youth politicians. Develop the long-term strategy state youth politicians, not falling under influence of political power and processes, calculated on all age groups of the young people, available and comprehensible each.

Conduct the expert operation all youth organization, having status «All-Ukrainian» on subject of the correspondence to their actual activity to authorized positions and program. A-UPPT espouses political, ideological and organizing-administrative independence All-Ukrainian youth organization. The structured reforms youth politicians state will allow to solve a problem incomplete cut-in a youth in life society, create the condition for shaping her new infrastructure, which, in turn, will allow: Transform the organizations student youth in real and independent organs of the home rule, having their own representatives in advice high school, organ of power and public structure;

Raise the scholarships a student before level 1000 GR all students of the free places, but - student before 1500 GR;

The efficiently to use the possibility of the network of the institutions of the culture and athletic basis. Joining youth to mass sport – condition of health of the nation;

Raise the quality of the rendering the services youth in sphere of the access to information technology, job placement and supports of the business initiatives;

Putting will obtain in this part A-UPPT into law about labour obligatory warranty right first worker place for graduate of the educational institutions, granting preferences employer, creating worker of the place for youth. In Law «About formation» additions about reorientations of the system of preparation specialist according to need market labour on base restructuring existing economic model on model «Economy of the knowledge's».

Balance the system a vocational guidance, adjusts the process of labor migration by conclusions of the intergovernmental agreements for the reason provision of social protection young specialist, working outside of borders of the Ukraine;

In condition of the crisis phenomenal to provide the possibility of the continuation and terminations of the formation. In this connection A-UPPT will obtain the decision making a government about granting the soft credits for youth, training on pay branches high school for the whole period of the education with partial redemption to account state and

return credit giver after completion of the training the credit- borrower. Simultaneously A-UPPT will obtain increase the scholastic places in high school to account of the state financing (the remittance of the payable places in earl free);

Create the happy circumstances for ensuring by home young family, improvements of the conditions of the life indigents, lost parental trusteeship children, young people – invalid. Revive practical person HME, regional tutorial advice, provide public checking by spending the facilities of the state fund of the assistance youth construction at Cabinet Minister. Lending young family is for housing construction to realize for period from 15 before 25 years through State Building Bank;

Conduct the inventory available in country baby and youth athletic fund. Prepare the project of the special law on his protection, use and development. Forbid the privatization these object in any forms, change the system and enlarge the amounts of their financing;

Perfect the work on shaping beside young generation of the people of the Ukraine priority sound lifestyle, preventive maintenances of the spreading NIV – infections, alcoholic and narcotic dependency, skills it is correct to build the rest.

Initiate undertaking in Ukraine of the annual festivals youth and student, for what form special non-government fund «New Generation».

A-UPPT will support all youth initiatives, directed on development beside young people of pride for country, patriotism, consolidation of the multinational Ukrainian nation, pulling to research activity, developments civil and public-political activity. In this connection A-UPPT initiates:

Creation and operating the youth public parliament at Supreme Soviets of the Ukraine;

Undertaking All-Ukrainian annual contest youth «Future Ukraine»;

Making the public youth chamber at President of the Ukraine;

Making the public commission on estimation of effectiveness of the reform of the public education and monitoring of efficiency her legislative basis.

Supporting any manifestations of the charity, patronage the motion, A-UPPT will be in every way possible call the youth to him. The centre of its attention we consider also problems vein, housing public facilities, sphere of the services and trade. The priority measure here we see following:

Development new legislative-normative basis housing construction, activity architectural advice, architectural-planning and design organization, checking organ;

Undertaking the inventory of whole housing fund of the Ukraine and preparation on this base of the most important subsection of the program «Home of the Ukraine» - «Social home», offering demolition old, outdated and dangerous for residence of the people vein and construction modern vein complex;

Forming the commission on checking the correspondence to requirements legislation, technical rate and presence of the material basis all organization and companies, got license of conduct building, reconstruction, restoration and repair functioning, allotment by their right of the review license and change main contractor, not keeping standards, quality of the building functioning and periods;

The development of the system state and public checking, periods of the execution plan construction vein, entering him in usage and reinforcements of responsibility of the leaders building organization;

Legislative fastening practical persons tap land area under housing construction solely on competitive base with obligatory public listening and advantage for state building organization;

Granting investor package state warranty receptions paid vein or return investment with penalty sanction not below average rate NBU;

For ensuring the financing the state target program «Home of the Ukraine» form the State Building Bank;

Develop credit-financial system under construction vein since period of the lending from 15 before 30 years and warranty of the return the loan and percent rate on 2% rates NBU below.

A-UPPT will be in every way possible protect the right an investor, defending them on all level, obtain attraction to criminal responsibility guilty in plundering embedded by people in construction vein facilities and participation state in compensations of the incurred losses. In this connection we consider necessary, contribute corresponding to change to law about investment and protection of the rights of the users. Amongst base problems of the improvement of the life of the people of the Ukraine A-UPPT selects the reform HME, the most painful, the most complex question of the connecting period. Exactly in sphere HME more whole escalate the governmental errors, most were sharply marked contradictions social device society, monstrous garbled principles of social fairness. HME less whole today answers the market relations. The managerial system by home and his usages, water-supply, overflow pipe and heat-supply is found in emergency condition. HME as were a go-between-monopolist, so them and remained, uncontrolled absorbing public facilities without visible improvement quality provided to services.

The enormous loss of water (before 40%), BPR boiler parka does not get to 80%. the natural monopolists (supply, gas supply and heat-supply), which, on the one hand, is, on essences, organ executive authorities, but, with another, his activity is not specified by law. Legislation of the branch not balanced, gives the ensemble a loopholes for abuses, for manipulate tariff especially. Technical retooling branches are not produced. The contents vein dispenses the people all cherish. The level of the payment of the services HME falls. Adding for housing-public servants grow, HME concern with the codicil of the nonexistent services, but the public has a no possibility to check their transparency and structure, more so activity subject natural monopoly. Does not exist legislative confirmed structures tariff and systems of the regulation tariff politicians. With people at payment of the services HME is unlawfully levied VAT. The contradictions in legislation about local organ of power give him possibility to evade the revising tariff HME from synchronizing. The government tries to replace the problem reprocessing HME on shoulder people themselves, to account payer taxes and services. A-UPPT calls attention government and folk that Ukraine all quicker is rolled down to scale housing – public catastrophe. A-UPPT, as really public party, expressing his will and interests, has a clear vision of the ways of the output of the country from housing – public collapse. Our program predestines:

Development, nation-wide discussion and legislative approving the new national program reprocessing and developments housing – public facilities on nearest prospect and up to 2020, conceptual reflecting improvement legislative and normative – legal basis, financial

stabilization, technical rearmament, improvement of the structure and managerial system in new social – economic condition;

The state expert operation of all legislative acts direct and mediated actions, referring to operation and regulatory politician housing – public complex, removal all difference in them and information in united housing code. In the centre whole legislation about HME must be a person and his house;

Undertaking the delimitations authority, state and local budget, concerning performances of the laws about activity HME, having provided increase the share of the taxes and collection, remaining in conduct local organ executive authorities;

The realization consequent demonopolization market housing – public utilities. Stimulation refusal of services go-between – HME and transfers their function to full-fledged Associations Co-owner Tower Block of the Houses (ACTBH), controlling companies,

with issue certificate, with transition to direct agreements electro-, water-, and heat supply with producer;

Entering the United State independent professional regulator of the prices and tariff on the market housing – public utilities, prescriptions and dictations which must have legislative power for all level HME;

The renovation in accordance with National Program reprocessing and developments HME for facility national budget main fund (heat trance, boiler, substation, gas networks and others) with the following their transmission in property, concession, control, or lease new well-to-do owner;

Transition to mass introduction in HME modern technology energy efficiency:

Isolated systems of the heating, production of the home electric power, consumption counter installation of the gas, water, electricity and heats, decision of the problem of the export of the rubbish and service adjoining territory. Provide installation a counter on favorable term (to account national budget, consent, and discount);

Change acting legislation, for making the favorable investment climate and attraction in branch of the facilities investor;

The development and taking the laws about concession, about associations co-owner tower block of the houses, procedures of the privatization public enterprise (except heating system), creation market services HME, their transparencies, competitions amongst producers with observance of the rights of the users, granting the possibility and mechanism of the supervision subject natural monopoly;

Introducing the complex system approach in realization social motivated tariff politicians, directed not on increase the expenses but on searching for variant their reductions, in accordance with concept of the pricing in sphere of the public utilities and antimonopoly by legislation;

Realizing regulatory function, state in system HME must provide united and unequivocal interpretation notion goods and facilities, define, as in conduct who is found, provide the clear requirements on obligatoriness performances;

The improvement of the order of the granting the privileges and subsidy to people on payment of the services HME, simplification of the procedure of their reception, liberation of the users of the services HME from payment of the value added tax;

Disambiguation in legislation about organ of the local home rule in respect of determinations tariff and right of their charging, delimitation authority local councils and their executive organ.

Synchronizing the order of the revising tariff, removing the statement and co-ordinations tariff from регуляторной of the procedure, obliging organs of the local home rule to revise the tariffs on facilities HME immediately, after change any one of them, as well as have a possibility of the checking of activity OCMD in a part quality contents of the houses and protection interest members of the associations.

A-UPPT comes from that that purpose of the reform HME – increasing quality services to population, their transparencies under greatly possible reduction of the expense. Amongst social questions our society, A-UPPT considers necessary to express its attitude to problem of the Ukrainian woman's, living today in situation of the awe for future their own children, in atmosphere of the discriminations and disrespects. The Ukrainian woman carries the life burden incompatible with her physical, moral and material possibility. The two-thirds of the people of the Ukraine, living for devil of poverty – women. The social help mother on care for child – minimum. In current whole of amount officially unemployed in Ukraine – 80% from the women. Such their percent accounts for Ukrainian labor migrants. From 15 before 20 thousand Ukrainian woman's annually perishes as a result of violence's. Length of their life for 10 years less, than woman's in Europe. Only 8, 5% our woman's are presented in legislative authorities, 2% woman's are an owner of the large business, at the average his section – 20% then women (woman) work at 4-6 hours more mans. Each third marriage in Ukraine disintegrates death-rate while that exceeds birth rate. In country enormous number homeless children. The purposes A-UPPT reach not only gender equality in society, but cardinal to change the state politician, public consciousness and moral in questions relations to woman. A-UPPT will obtain approach to European standard of protection of the feminine rights; render utmost support feminine organization in realization their public-political and social project.

Here:

Increasing of the living wage and real minimum salary to living wage in two times;
Increase the volume of the budget on rendering social help for woman's with children, social help full-grown on care for child before 3-h years before 50% living wage, provide the construction state All-Ukrainian rehabilitation medical centre full-grown and child;
Granting the free treatment in institutions full-grown and child woman and their sick children on conclusion of the medical commissions and organ of the social trusteeship;
Develop the State programs: «Fund of the future generations» and «Maternal capital»;
Prepare the project of the law about introduction Ukrainian order «Maternal glory» and positions about him;
Obtain the realization of the right of the women to combine the work with parenthood, working with state compensation of the difference employer incomplete workday six hours, and contribute change to law, providing criminal responsibility for breach equality rights of the woman's in sphere of the functioning;
Create the efficient system of protection of the woman's from violence:
State centers of the rehabilitation of the woman's, practiced violence, granting to him free legal help.

Initiate creation an All-UPPT feminine public body «Forum of the Ukrainian woman's» and international fund «Parenthood» under her;
In state budget of the country and budget region to provide the article of the expenses on gender to themes;
Introduce gender component in system Ukrainian legislation and formation;
Revise the level a pension woman's aside increase not less 50%, from, existing.

A-UPPT expresses get fat solidarity and support of activity of the Ukrainian federation trade union, independent trade union in their fight for right toiling, reprocessing systems of the payment of the labour and develop her level in unit of the prime cost of the product to European standard (before 40-50% instead of present 14%), increasing of the living wage before 1700 GR at month, conservation of the social privileges and improvement of the conditions of the labour. A-UPPT stated that in condition social-political and economic instability in Ukraine, our society needs for change state-legal politicians, deepening judicial-legal reform, development of the special measures state anticorruption program. The firm mistrust of folk formed in country to law-enforcement system:

Public prosecutor's office, court, police, tax and customs organ. The corruptions, bribery, embezzlement of state property, extortion become their visiting card. Today 80% people do not entrust one, is obliged to guarantee protection of their rights and liberties. The judicial reform sprawled on two decennial events nearly, effluent in chicanery between judicial and executive power. The courts try to create «Caste the untouchables», singular alternative executive authorities, «State in State», fraught final destruction statehood. A-UPPT considers necessary:

Create Special united commission of the Supreme Soviet and Government on estimation of the condition of the judicial reform, reforms all other law-enforcement organ. On the grounds of totals her functioning to contribute the offers in Supreme Soviet about approving the changes to their reformative process, including: Cancelling the judge's inviolability for frame of execution of an office;

Return to system election judge high location with parliamentary choice simultaneously;
Revise the laws «About judiciary of the Ukraine» and «About high the advice of the justice», about purpose judge on administrative job titles in court and others;
Simplify the system a proceedings by means of liquidation of a part intermediate judicial location and her consolidation;

Contribute the addition in legislation about possibility of the change the territorial jurisdiction;

Provide the reinforcement of criminal responsibility judge and employee law-enforcement organ for breach of legality, law and order and oaths;

Introduce in practical person proceedings institute juror assessors;

Revise the laws about system of the performance of the punishments of the Ukraine aside her liberalization;

Contribute the changes to acting legislation, directed on protection of the poorest layers of the population;

Contribute the offers in Supreme Soviet about the further reorganization SSU, Home Office, government protection, public prosecutor's offices, other state power structures. The main purpose – increasing of the authority their employee amongst people of the Ukraine, exceptions of the manifestations of the corruption in law-enforcement organ,

improvements of the system of their operation, increasing of efficiency of the fight with criminality, for decriminalization public and economic life.

A-UPPT considers also that, either as armed power, the number of the other power structures must be provided in correspondence to with requirements public democratic state. On today number of the militia in three times exceeds the number of the army. The Ukraine must not become the police state. This disagrees the principle of the nationality and democratic defense policy and army A-UPPT notes that on background of the development of the global economic crisis and intensifications fight for world leaderships, increases the international tension, grows instability, is accumulated conflict potential, are saved internal and external threats of national safety, increases arms race when narrowing dug OON, OSCE and their adjusting legal mechanism. The Ukraine turns out to be the most vulnerable countries in count; calculate; list. However for not today direct military threats no. Where dangerously internal: Incompetence and weakness authorities, low efficiency her institute;

Corruption whole powerful vertical, trading national interest in please oligarchic clan;
System political instability and reinforcement of probability of the determination of the authoritarian mode;

Presence of the problems ethnic, ideological-political, confessional of the nature and foreign-policy passion region, capable to cause the disintegration processes and schism society;

Deepening the crisis of the national economy, creating danger of the loss of the economic sovereignty of the country;

The disastrous impoverishment of the population and unprecedented growing discontent by power, forming premises of the social blast.

Together with that we shall acknowledge existence for national safety of the Ukraine and external threats. Amongst them:

Economic nature:

High probability of the loss of the economic sovereignty by transition strategic asset under checking of foreign funds;

High probability of the loss market traditional article of the export;

The undermining of the international confidence to status of the Ukraine, as reliable transit power resource;

The growing of the insulating the Ukraine from world and regional economic integration process.

The political nature:

Uncertainty of the row of the countries EC in estimation dug and place of the Ukraine in world community;

The danger of the conversion of the Ukraine in zone rivalry USA and Russia for dominance in region and reinforcement of the influence upon post Soviet space;

The policy USA, supported by Ukrainian manual, beside countries EC and Britain, directed on draw Ukraine in UNO, notwithstanding will majority Ukrainian, led to deterioration Ukrainian-Russian relations;

The breach of the balance of power in Europe, established after disintegration USSR, Warsaw of the agreement and extensions UNO on orient, caused growing of the tension between Alliance and Russia;

The longing USA by means of creation centre tension on euroasiatic theatre to compensate to account of other countries of the loss, incurred by them as a result of global economic crisis, undermining of the international authority from wars in Yugoslavia, Iraq, Afghanistan, escalations of instability around borders of the Russia, in Pakistan, Iran, Black Sea region;

The attempts Turkey to support the separatism and influence on cream through organizations and communes Crimean Tatar;

The territorial disputes with Rumania around Island Snake and continental shelf in Black Sea, her claims to restriction navigation on Ukrainian part mouth Danube, on a certain part Bukovina and Bessarabia;

The unsettled status Transdnistria, his frozen conflict with Moldova;

Stay Russian Black Sea fleet in Sevastopol, separatism of a part of the population the Crimea, unachieved delimitation area Ukrainian – Russian border in Sea of Azov, Black Sea and Ketches strait;

The arms by Ukraine of the criminal mode M. Sacashvili, parcel military specialist in region georgian-ossetic of the conflict and their participation in combat action on party Georgia, official support Ukrainian power Georgian aggression, created danger of draw Ukraine in war with Russia, conversion of her image by diligences of the President Uschenko from strategic partner in enemy of the Ukraine;

The danger of the manifestation in Ukraine of the international terrorism, caused by support Ukrainian power antiIslamic of the wars USA, camouflaged under fight with terror.

The growing of illegal migration through Ukraine, hits international piracy, illegal sale by Ukrainian power of the arms and combat technology in regions conflict in pass-by inhibit UNO.

Ready Ukraine to withstand this threat?

We consider that without qualitative change parameter armed power, only somewhat. The Ukraine is required modern army, capable adequately to answer the threats, capable real to provide safety of the country and her people. Manual of the Ukraine emphatically pulls folk in EvroAtlantic Alliance, convincing him in that only UNO capable to provide safety our Ukrainian state and take care about development of our defense industrial complex. At the time of forming the independent Ukraine we had one of the most powerful army of the Europe. Today this miserable her mold. The retarded armies tear main fund, undecided social problems, non-payment soldierly contents, groups of ten of a thousand military personnel, not having vein, problems with uniform, power supply, and hospital by treatment, reduction scholastic- material basis. The resource of the technology is perfected from 50 before 85%. Herewith, 95% product Ukrainian OPK goes on export and only 5% are bought for its army.

All are these years was winnowed unrestrained sellout military property and armies, inherited from USSR, not conceptual reduction of the trained composition, structured reorganization, only not construction of the new army. Was not created domestic independent is defended-industrial complex. Rescued from selling the weapon and technology of the facility were used not on purpose, did not go on necessities of the armies, on development new technology, making the modern armies. Today financing of

armed power is reduced before critical level – less one percent GDP. The service, in armed power of the Ukraine ceased to be of interest and prestigious. Conducted on recommendation NATO and under their care reprocessing, nothing, except harm of armed power of the Ukraine, has not brought. The Ukraine, possessing necessary scientifically-technical potential, nucleus, chemical and racket-cosmic production, able by itself to develop the conceptual bases of the military reform and successfully incarnate them in life. A-UPPT considers the most acceptable for Ukraine status nonaligned state with active neutrality, and will obtain fastening of this position in constitutions of the country when ensuring the international confession and warranty UNO, OBSE and NATO, ODKB and CIS. A-UPPT supports initiated KPU public motion «For nonaligned, Neutral Ukraine». This will give the Ukraine a possibility: concentrate the efforts on provision own national interest and realize its politician military-strategic and defense planning;

The Ukraine will leave from sphere states political collisions two centers of power;
This will enable for determination constructive economic and political relations on axis orient – west;

Will remove the danger of retraction Ukraine in conflicts of the third countries;

Will influence upon reduction public-political opposition inwardly Ukraine;

Will consolidate the authority of the Ukraine in the world, will provide her safety and territorial wholeness.

Coming from democratic device state, army of the Ukraine must be public, built on professional – call-up type of the organization in correlation 60:40. On confession nonaligned status of the Ukraine must be based development of the new military doctrine state, which must become more concrete and more applied, on all amounts answer the national interest, rather than interest of the block NATO, create the most-favored nation treatment for realization of the military reform, directed on rebirth domestic OPC and construction, modern Armed Power. Having refused in unilateral order from nucleus weapon, Ukraine has demonstrated the world that does not be going to or on who attack. Consequently, nature of the new doctrine must be defensive, founded on principle sufficient perimetritic safety.

Together with that, she must reflect change an states political and military-political situation in the world, including increasing dug military power in politicians, contain the priorities reprocessing, purposes and periods of the realization of the program, and reflect the complex approach in realization of the reform. Acknowledging potentially dangerous local conflicts in close proximity Ukrainian borders, A-UPPT comes from that modern wars will be conducted usual, first of all high-precision weapon with possible threat of the using nucleus ammunition. The doctrine must acknowledge the broader circle of the threats, than previous, as well as possibility of the decision their not only military measure of the reaction. Herewith bolt the rate, according to which Ukraine can participate in frontier conflict on perimeter of its territory for the reason enforcements to the world , where is realized breach principle international right, falling under determination of the aggressions in respect of her people. This defines the priorities of the development of armed power of the Ukraine:

Missile troops of the average radius of the action of the mobile basing;

Power of the quick reaction (the aero mobile), formed from professional;

The tactical aviation and complex system NADGE;

Naval power, carrying combat maintenance standby in area of water black and Mediterranean seas.

On base of the new military doctrine must be designed military-industrial policy, oriented on modernization of the arms and technology, creation their most latest sample, development research and research and development functioning in the field of provision defense capacity state. Providing increasing of the export potential in the field of international military-technical cooperation (MTC), new military doctrine must be, is directed on creation domestic OPC, production of the latest armies, including «untraditional weapons», founded on information technology. Revising priorities of the development OPC, we consider necessary to remove military-technical cooperation, with RF first of all and China in facility of the research integration OPC Ukraine in world economy. A-UPPT considers necessary to enlarge the military budget of the Ukraine before 2, 5-3% GDP. Provide the defense order and share of the military expenses, directed on buying the military product before 20% that will provide the consequent reduction of the export dependency of the defense sector of the economy, will allow to avoid unbalanced military production, bring the structure of defense industry of the Ukraine in correspondence to her need for armies and military technology.

A-UPPT considers this problem for defense industry, in context of the change military-political status state, the main. The problem restructuring defense production Ukraine can solve without destructions one and creation new production through different mechanisms is defended-industrial cooperation and integrations. In this connection A-UPPT considers expedient to conduct the state inventory all enterprise OPC, having selected accompanying for transmission in FGI and their following privatization. Take away from sphere of control mo public industries, burdening her structure (on repair of the arms and technology, building complex, the rear, forestry and agricultural, on adaptation dismissed in spare military personnel and conversions former military object and others.). Simultaneously bring back into state property enterprises, having strategic importance for ensuring defense capacity country. Coming from that program reduction defense sphere, including, construction new armed power of the Ukraine is ruined, A-UPPT considers that preparation persisting reforms will take up to 5 years, but for final judgment will take not less 10 years. At starting-up period must be created not formal legislative basis, is designed and accepted program:

Reaction and developments of the facilities of the cosmic defense;

Shipbuilding;

The systems of the antimissile defense (possible, as a part European collective);

On base of the positions of the military doctrine is designed structure of armed power, is determined by her numerical trained composition, is calculated to need, is created new system in the rear provision. Together with that, A-UPPT considers necessary to take the most emergency measures on maintenance on required level of combat readiness of that troops, which Ukraine disposes today.

In this part:

Legislative to forbid under any circumstance to disconnect from energy-supply part of constant combat readiness and home systems of life-support troops, having provided for leaders enterprise provision, entering notwithstanding law, criminal responsibility for sabotage and undermining defense capacity state;

Neither excludes, under what that nor was a pretext sequesters of the budgetary funding, determined on defense sphere;

Provide operating the effective system of social protection military personnel, their family, address help dismissed in spare, increasing pension military retiree and participant combat action. Provide in correspondence of the pensions military personnel, dismissed in spare before 1993 with pension, added after 1993.

Before 2011 raise military personnel base salaries money allowances in two times, revise and return net of the additions for particular conditions of the service, enlarge length a furlough, restore earlier cancelled payments for food soldering, make the uniforms, payment of the journey in transport, payment bonus and furlough on household circumstance;

In earl states budgets «Costs on the defense» separate line to provide the highlighting of the facilities on construction vein for military personnel;

A-UPPT considers, for fortification of the authority of the army, creation of atmosphere of the real respect to protector of the Native land, increasing of the motivation of the soldierly service, take the law «About state warranty guard, protection honor and value military personnel Ukraine», which bolt for military personnel status state serving with all resulting thereof social-legal aspect;

A-UPPT raises an objection to participations Ukrainian military personnel in military operation and combat action on military plan of the third countries, exclusive of peacemaking of the operation on mandate UNO and equal with country EC financial, material and legal provision; Contribute the changes to law «About alternative» (nonmilitary) to service;

A-UPPT will actively support all public bodies, espousing support of armed power of the Ukraine:

Committee soldier full-grown, feminine council and others external policy by the most important factor of the provision economic and social development of the Ukraine, provision of safety of the peace life of the people, is comprehensible, weighted and responsible external policy state, expressing interests not depended or oligarchies clans of the structures, but the whole Ukrainian folk, guaranteeing his worthy present and future. Today A-UPPT with certainty declares that all years of independence of the Ukraine her foreign-policy rate was realized in full take-off from moods and necessities Ukrainian society, particularly deepened after 2004 in condition the situation has worsened political conflict between party, clan and branch authorities. The war of Ukrainian political elite «all against all», accompanied endless «cassette», «gas» and other scandal, has brought about disastrous fall of the confidence of folk to the authorities and undermining of the international authority of the country. As a result thoughtless euro-integrated and pro-atlantics of the rate puppet Ukrainian authorities, country has got the virtual external politician, such «associated proximity» in atlantics mirage. The full collapse in external politician, Ukrainian FM – main is prostituted before west organ with shamelessness presents folk, as prominent success of the domestic diplomacy. Having declared very important in external politician fight for international confession starvation genocide of Ukrainian folk, blindfolded pro-NATO and anti-Russian ideas power, has not discerned the most essential states political (geopolitical) of the changes to the world. In total, the Ukraine turned out to be in insulation, both with orient, and with west. By a narrow

margin reached membership in vein and longing to get the simplification of the visa mode between Ukraine and EC become expensive unilateral motion. The power has irresponsibly pushed the Ukraine between three «centre of the power», having done her hostage their states political interest. In total EC, Russia and USA have for a long time written off the Ukraine from their own priority. Since our politicians demonstrate inability to meet commitments before EC by reason of internal faction, on the one hand, with other – idea membership in NATO does not support the big part Ukrainian society. Without consolidation society and the authorities, pragmatic foreign-policy rate, Ukraine can turn out to be in dug the object of the influence, «independence» which is provided by balance of power main global player, on one side which administration of the President and FM selects USA, Canada, Great Britain, France and Poland, on other – Russia that differ the extreme recklessness.

The most block of the problems, notwithstanding greater agreement about friendship and strategic partnership, Ukrainian power by its anti-national external policy created in relations with the main states political neighbor – Russian Federation, where particularly serious are: Incompleteness is contracted-legal registration of the total border with delimitation area of water Azov, Black Seas, Ketches of the strait and use Continental Shelf;

The loss by Ukraine of the initiative and weakening her position in adjusting Trans-Dniester conflict;

Dissociate Ukraine from regional integration processes with participation of the Russian Federation;

The contradiction of the longing of the Ukraine to European integration with questions of the provision of national safety of the Russia;

Stay Black Sea fleet RF in Crimea;

The rolling up trade-economic and military-technical cooperation. The loss in this connection traditional sales market, destruction industrial cooperation, deprivation of the orders OPC, refusal of services of the labour, research interaction;

Energy, gas-transport, trade and diplomatic wars;

Questions of the humanitarian sphere:

No recognition of the international rates Ukrainian labor migrants in Russia, economic enforcement to acceptance Russian citizenship, politicization questions of the history, problems of the Russian language in Ukraine;

Attraction CMI to making the image «enemy with north», undertaking politicians «small provocation»;

The position of the Ukrainian President in Georgian-Ossetian conflict, arms by Ukraine of the Georgian army, parcel Ukrainian military specialist, taken part in combat action against Russian peacemaking of power;

A-UPPT considers the wrong failure of the Ukraine from interview of the process on EOP, making the united customs alliance, free trade zone, participations in ODKB, in structured organ CEG. With output from CIS. The Ukraine definitively lost the influences in this alliance and turned out to be in full insulation, forfeited status of the south regional leader on post Soviet space. The Ukraine did not be able to defend its position in territorial

dispute with Rumania, herewith not finding supports neither beside USA, nor in EC, nor in CIS. Created on the initiative USA association UGAM (Ukraine, Georgia, Azerbaijan, Moldova), prospects has not by reason of weak institutelization and absences of the interest to him trance-national of the companies, straightening the new architecture political space in Black Sea region. The absence resort provision evro-aciatic energy-transport of the corridor,

Dissociate Azerbaijan and Moldova from this glue ware formation, absences of the united position of the countries in respect of adjusting ethno political conflict. A-UPPT will with regret acknowledge that in external politician of the Ukraine due to acting authorities has approached the twilight. The system states political brocades forms around Ukraine. The country is deprived enjoying full rights participation in international mechanism financial-economic and trade regulation. Increases degradation technological and industrial potential. Make progress the loss of competitiveness Ukrainian goods. Grows the threat of the loss of economic independence. A-UPPT, leaning on the most important principle modern ethno political – need of the fortification and developments multipolar world. We consider that ethno political rate of the Ukraine must be founded on national interest of the country, implying:

Provision of national safety and international stability, conservation of the world for folk of the Ukraine;

The conservation to historically inherent Ukraine states political status in Europe, coming from inevitability, both partnership, and competitions, achievement European level and quality of the life;

Reconstruction economic, political and cultural relationships with country post Soviet space, with idea of broad unity Slavonic folk, not bound neither with communism, nor with fascism, nor with nationism, directed on conservation east -a Slavonic civilization;

The refusal of foreign-policy of the decisions, unacceptable for oppose centre of the power:

EC, USA and Russia, transition to status nonaligned state with the policy of the active neutrality.

A-UPPT considers that Ukraine must not knock in door European «card building», but build its, where her folk feel the comfort and welfare. Only then us will respect, and be considered with us, as true proprietors of its land. This refusal of conflict and participations in opposition on party one of collide parties, cooperation with international alliance and associations without entering in them (NATO, OBCE, ODCB, SHOC), the policy neighborliness and trans boundary cooperation.

A-UPPT comes from that that USA conducted, and will conduct anti-Russian politician, using Ukraine as buffer, pushing her with Russia for achievement their own states political interest, transforming in puppet of the west. We must abandon to such dug in term of the shaping the new architecture peace-facility and concentrate on internal problem of the country, excluded confrontation, both with west, and with orient. This dictates life itself and such her factors, as:

System crisis Ukrainian authorities, abscess of the political system, not giving possibility concentrate on background questions internal and external politicians, leading to authoritarianism decisions and, as effect, to collapse and problem;

The economic weakness of the country, danger of the oncoming economic chaos and ruin, impossibility to find the facility for ensuring active foreign-policy rate;

The absence thought-out, integrated, deeply defense modern concept external politicians. The schism of the Ukraine on adherent west and east vector of the political orientation, creating danger for conservation of wholeness of the country;

The professional weakness of the domestic diplomatic body, manual FO, subject to influence fights political power and branches authorities;

A-UPPT certain that as a result reserved, wise and weighted external politicians of the neutrality, Ukraine will obtain the fortifications of the authority, productions lacking today conceptual, will remove the ensemble of the complex problems on axis west – orient, will form the public opinion comparatively existing split priority. We consider that this corresponds to the interest of folk and moods of the public.

A-UPPT sees need, for the reason lifting the economy of the Ukraine, develop and take the State Target Program:

«Atomic-hydrogen, hydrogen, alternative renewed energy and fuel elements, nanotechnology and nonmaterial's Ukraine», and organize making the State National Company «New ecological and energy» projects» for the reason attraction trance national investment facilities, realization of the comprehensive program energy conservation, increasing of energy efficiency of the use the renewed sources of the energy, as well as new High Technology. A-UPPT will settle the problem of the participation of the Ukraine in International Ecological Project «Peace hydrogen and energy» and making the International Technical Consortium «New ecological and energy projects», with country EC, BSEC, APEC, B.R.I.C., AFM. The task of the international ecological project «Peace hydrogen and energy» – development and introduction in everyday life, and modern production new, unique developments in the field of High Technology, which are an equivalent free converted currency.
