The New Economical, Political and Ideological Thinking of the taxpayers of the world countries within the Transnational, Ecological, Legal-Economical Project “LIFE” and World Assembly of Taxpayers’ Parties Creation.

What is the portrait of a modern official? But do you know that all the political parties of the world are the parties of officials and their surrounding? And what can you do when our state is attaching to the hands of talent officials?

Remember that the taxpayers of the country are the economical base of any state of the world and the source of its budget creation.

The peoples of the world made a rude mistake which had not been corrected till today when they set a mediator-official between themselves and the authority. They delegated him their right and authority, but he abuses the people’s trust and tries its patience and creates fantastic privileges, high salaries, comfortable life conditions, jeering at the people openly.

People pay to the officials who are extortionists and bribe takers to accept the legal and justice decisions on all levels of the state authority at the state. The officials, being on their bought positions, think that the law is a pole, which can exit where it should be turned.

The officials wrote strict laws for us, taxpayers and their families’ members, and require us to execute them under the fear of a punishment. And, as they have our poverty, they require the people of the country (taxpayers) to give them the last financial means which we have to provide their maintenance and to satisfy their needs.

The officials, practically all over the world, even legalized their state holiday called it “the Day of the State Official”.

The Day of the State Official is a holiday of people who are serving to the state and the Ukrainian people. People call them simpler – they call them an official. Everybody of us have to talk with them from time to time. And the most part of us doesn’t feel a delight from these contacts for a pity. Unfortunately, the negative aura tightly surrounds the modern official. What can be changed here and how? Not one generation of officials’ clients tries to find an answer to this question. Some of them suppose that all these negative involvements are because of the feeling of self-esteem absence, other ones think that it is because of the low salary, third ones state that it is because of officials’ incompetence etc. There are many reasons. But is it possible to combine such conceptions as “an official” – “respect” – “authority”?

Nobody from the outside will do a modern official respectable, and nobody will increase his authority, if he will not take care about it himself.

Firstly, today the officials are the full owners of the life. There is an absurd situation which makes an impression that the society exists to serve to the officials, but not vice versa. There is a fault of the society in it too, of course.

The stated above doesn't touch absolutely all of the officials, of course. There are conscientious people who work honestly. But there is a very little part of them. So, the problem is in a fact that the authority of a modern official among the people is not a value for him at all. An official, which has no an authority among the people, can be wide respected by his chiefs, if he is obliging, executive, punctual etc. You understand yourselves that an official won't be in his position a lot of time if he will good for the people and non-comfortable for his chiefs.

Therefore officials choose the serving to the upper chiefs, but not to the people. This is the reason of their "authority" at the higher level. But the authority among the people and the official's attitude to them must be the main score of the official's activity. It is necessary to establish such form as questionnaire design of the people with whom he works within the officials' attestation practice, as well as to provide the absolutely objectivity and openness of this questionnaire design and to count it the first score of his professional validity within his professional qualities scoring.

There is a long-term dispute about the responsibility of our officials. It is a fact that it exists "de jure". The legislative norms foresee the responsibility of an official at the Criminal and Administrative Codes.

But the problem is in a fact how do these norms applies to the officials? In my opinion it is necessary to deprive an official his administrative functions to make him respectable indeed. Then he will be in the same position with a customer and live by his interests. It is necessary to create such conditions for the official as make him to report to his services customers about the reasons and methods of his steps, to stand everything from the legs on the head. The citizens will wish to use a possibility to control the official with time. There will appear a normal situation for the developed citizen society in which the citizens are checking up the plenary powers delegated to the authority using as well as controlling it and check the executors.

Beside it, not the official's plenary powers only must be determined, but also the price of his services. It was worked out a document where the administrative services of the poverty had been counted. The price of a pen, paper and human's expense only must be included to the value of any inquiry. Not more. So, a paper which today costs about 120 UAH must cost not more than 2 UAH indeed. All charges "to the building of a road" or to anything else must be excluded. Any official's deviations from the valid tariffs must be punished by the criminal or administrative responsibility. The statement "The Client Is Always Right!" must be hanged above his table like in a shop. Then "an official – human owner" will learn to smile to a citizen and to want to do something for him.

Based from the middle statistic salary at the state, it is necessary to establish the big salary for the communal officials to make them not interested in bribes, based on the risk to lose a high state position. It is also necessary to determine legally the punishment for the bribe-taking and other abuses of the power on the state service. Unfortunately, our laws

contradict to each other and also one half of the laws are not active. Therefore the officials use a principle "I execute the law if I want, and I ignore it if I don't want to execute it."

The applications to the different managing structures can be looked up during several months or not be looked up in accordance to its mean. Here should be good to less the middle branches in these structures in two times at least, to stimulate the education and self-education of the officials, who regretfully inherited the traditions of the Soviet period, as a lot of simple citizens indeed who have not got used to solve the problems with the officials at the law-courts.

Though, we have to realize that the legal competence of the judges is often on a low level. Generally it is impossible to live so as we live now, taxpayers. Will it be possible to change it in the nearest future? I am well sure that we'll be able to solve our social problems indeed if we'll create a taxpayers party at the country. I am also sure that our active life position will be able to change the situation to the better. We, taxpayers, can stay everything on its places in our life.

Today the main problem of the state service in Ukraine is the low budget financing, as many officials suppose. An ordinary employee of a state institution gets in three times more than a worker at a factory in general, and it is more difficult to provide all the necessary for himself and especially his family with this salary, as he thinks. It often makes an official to look for other ways to get the necessary financial means, to use his official position to take bribes for example, which creates the first wave of the negative emotions, accompanying the image of an official. The people will breathe by the full breast, if the quantity of officials will be reduced on 80-90 per cents.

Moreover, today there is also the second, psychological aspect of the means shortage for the officials' maintenance. It leads to the gradual liberations of a lot of vacancies at the state service. The truly professionals don't want to occupy these vacancies because of the size of the salary. So, it is a fact that primordially only non-professionals, knowing that they won't be able to work for the bigger salary or people for whom the state service is not profitable. It is impossible to lead a speech about their competence in both causes.

Shorting the officials in the mass order, we, taxpayers of the country, will decide two tasks in the same time.

1. The free budget means we will lead to solve the social problems at the society.
2. We'll decide the main task of the specialists at the industrial area. We'll lead the officials to the real sector of economics.

On the other hand, the chiefs and more experience colleagues often accept employee's offers without enthusiasm if he expresses some rational ideas or if he wants to increase the level of his activity. They often say in these cases, "Whom did you decide to learn?!" If this position takes place, even if a human comes to the state service as a specialist he will transform to a traditional official during the time, which owned an offensive principle "Nobody needs my efforts. For what must I try?" All of it transforms in a high degree of angeriness. This angeriness the officials splash out to the people around them.

The better an official will provide the citizen's rights than more problems he will deliver to his colleagues, than less will remain for the officials' society. At that the more important question for a citizen than more chances to get a bribe in the private order for the official. So, there is the principle of an inverse proportion of the interests of an official and a citizen.

To tell about the official's authority, first of all, this problem is solving by the normative state documents, which determine the competence and the rights of the official. But it is more difficult with the respect to the official. It is the emotional acceptance of the official by a simple citizen. It can be better if the official will be attentive, friendly, respectful to a human, if he will have all the necessary normative documents knowledge and a possibility to accept the decisions correct and without assistance and not put his functions to other people. At that the power, given him by the people and financial reward must be proportionally. The less this disposition keeps than there are more stimuli for the official to use his power in the goals of his bean.

From my contact experience I can notice that the respectful disposition had been kept to the officials who were the relatives or good friends, or people, with whom it was possible to find the mutual understanding after often meetings. At that there were no any exactions.

In spite of the non-respectful disposition to the officials and blame of their actions, nevertheless there are a lot of people even among the higher educational institutions graduates, who are full of their wishes to go to the state service. The stability, let it be even the relative one, a carrier growing possibility, relations, acquaintances and, at the end, the state pension are the stimulus to go to this area. However, as I know, the state clerks don't get a lot of money in other countries, at the USA in particular. And nobody wants to be a clerk there.

Vice versa, our officials require to pay them not a lot of money only but as much as it if enough to the wealthy life, entertainments and leisure. And to establish the strict control about the bribe taking at the same time, which should be liberating from the job and depriving a right of the further employment at the state service.

The bribe taking and too developed bureaucracy is the most serious problem which is the reason of non-respectful disposition to the state clerks now. If it is necessary to prevent the first one using the strict measures, but the bureaucracy, which have appeared already at the Sumerian culture, still exists now and, as it visible, it will never disappear.

There are often no reasons to respect the officials. Bureaucracy, staleness, formalism, non-attentive position to the peoples' needs are things which we have to feel when we're applying to the state human within the work as well as by the private problems. The official's arrogance and haughtiness are especially unpleasant. When you're entering the office, they're looking at you as at the boring petitioner who is distracting them from the important affairs. They forget that they were appointed to their positions for the people, and not the people exist for them. It touches not far from everybody, of course. I worked with very respectful, attentively and high-professional specialists.

By the way, the human is more competent, than he respects more a professional in his interlocutor. When you're going to the reception to an official, it is possible to understand at the first moment, is he going to solve your problems or is he going to hold things up. Than there are absurd requirements, some intricate conditions which are not supposed by the standards and law, which are appearing in that moment. It is getting clearly that the speech is about secret and sometimes even completely open extortion. Sometimes an official behaves so, as he should make you a personal benefit, favor, but not executes his duties.

It is impossible to reach the respect to an official by declarations. Today already nobody will respect a human for his position only, for a fact that he is a state clerk. A clerk

can find respect to himself only by his competence and wishing to solve problems by the serious way. I think that also a regular “clearing” of the clerk rows could help. Because in our country a human one time will get into “wide range” as talking among the people, and already gets a right not to go out from there for always time, even as he works very badly.

Today many people would like to be the state clerks. It is clear: the salary is guaranteed, a pension is counting in accordance with the discount standards, to compare with all other people. There are some people among them who put the papers all the life and feel comfortable on their pension afterwards. The work of some clerks is difficult indeed, it is complicated, and it requires from them the serious knowledge, readiness to accept decisions, to be responsible for them, and they are worthy of respect for their work under a condition that they execute their duties with the high quality, but there are some separate people among them, for a pity.

23, June, in Ukraine, and 9, December, in Russia, and also in other countries is celebrating the Day of the State and Municipal Clerk, or the Day of the State Service. But there is a paradox that the Supreme Rada of Ukraine, for example, denied to recognize medics, teachers, and military men as the state clerks. It states about a fact that our money which came to the budget, are using by the officials to create comfort and privileges for themselves, which are strictly keeping by them from the taxpayers.

The state clerks, having the working experience at the state institutions more that 10 years, have an additional paying vacation till 15 calendar days. But it is exactly for our account. By the way they are getting the financial aid, health care and many other subsidies, which were worked up by the officials themselves. But at the same time the workers of the heavy professions and enterprises which are harmful for the health, scholars, children and other categories of the citizens can't afford to themselves even milk which is recognized by the law.

At the current stage of reforms we, taxpayers of the country, put the tasks to enforce the social protection of the state clerks and to accept the measures to increase the quality and efficient of the work of the state institutions, based on the standards of the state services providing. But also at the same time we are establishing a question about the large scale shortage of the officials' rows, because they are simply doubling the work of each other and not responding to the taxpayers' requirements to their work quality for the profit of the people of the state.

The force of the state is in its state clerks, in their possibilities and wishing to develop the country, to make it modern, successful and safe. As well as it is in their possibility to think free, to work independently and to make the citizen responsibility and initiative on themselves.

The efficient development of the country is depending from their professionalism, experience and eagerness in many items. The state clerks must suitably execute the most important task to serve to the state enforcing activity and to work competently in the citizens' interests.

But the officials in a state to all the state positions must be recommended, appointed and leaded by the taxpayers' party to realize the national legal-economical idea, worked out by the taxpayers.

Let's ask ourselves: in what we, taxpayers of the country, are worse than the officials whom we support? We exactly provide the material benefits; we're the economical base of the state and the source of the budget creation, but the privileges and the life advantages are using by the officials exclusively.

Why the states and their leaders don't declare and don't celebrate, "the Day of a Taxpayer of the Country", for example? It is because they are panic afraid of the national and political uniting of the taxpayers not in their country only, but also all over the world, against the officials. It creates exactly the new national idea, new economical, political and ideological thinking of the taxpayers of the all world countries at the struggle with already unbearable officials' despotism.

But it had been declared "The Judgment Day of a Taxpayer" by the state officials for us. It means the criminal and legal responsibility, standard acts about taxpayers' responsibility for the tax legislation violation and other papers which were worked out by them for the struggle with us.

The Tax Codes of the states don't give a determination, but show the persons who are counting as the taxpayers at the current day. There are physical persons and legal organizations. At that organizations and physical persons are opening at the Tax Code. And it is important that it is reproducing the statement of the Citizen Code of all the countries indeed. Consequently, the state institutions aren't taxpayers and can't be them. INTERESTING!!!

But, talking about the common sense, even in accordance to the pure formality moments from the TC articles, they can't be taxpayers, because they are neither the physical persons nor organizations, as organizations are describing at the articles as the law persons which were created in accordance with the legislation of the country, but today the law persons are creating in accordance with the citizen legislation only.

And the state institutions are creating not in accordance with the CC, but with the other legal acts for the officials, and they, officials, don't so want all taxpayers to know about these documents.

The secret decrees, declarations and other normative acts appear from the official's pen, and it is a secret from us, taxpayers of the country and its people.

Therefore we can make a conclusion that the state institutions can't be taxpayers in any way. But the state organizations can show themselves as the tax agents, which are the tax collectors and taxpayers' life usurpers. They, clerks-bribe takers, learn us for our money how to live, learn the life in the state, and rob us and our families under their speeches and slogans for the people.

The clerks of all the ranks, always speaking forward the people, underline and note, that it is impossible to imagine the activity of the authority institutions at the modern state conditions without them and their high-professional service, which is addressed to provide the economically based, democratic, legal and resulting management on any level of the state authority.

There is creating an impression that they much wish to oblige and serve us, taxpayers, but for our money, to impose by a regular tax, to create a regular decree about the people exactions and feeling the budget basket, people's means collection to maintenance their immense cohort.

It is prescribed at the legislative of every country for every clerk that the first regular requirement of the time for them is the high principles of their people, democracy, law, humanism and the social justice service observance.

The holy duty of every clerk is to observe the constitutional rights and freedoms of the citizens, to create the conditions for the stable economical and social development of the country, to help to the advancing of the people's life level.

Clerks must remember that the social trust in the authority is beginning from the any state clerk, which had been accepted to the service by the people in the quality of an anti-crisis manager, which is supporting on the taxpayers' means which provided him large rights.

People must always feel the clerks' work to the tasks of the social-economical development of the region, life quality in the country increasing, but there is no this involvement in any state of the worlds, thought it is very strange.

We always wish the state officials the creative inspiration and well-being, healthy and the private happiness, as well as the new performances in this important, responsible and difficult work to manage the state actives and multiplying the state property. And they reply us with the "mutuality", their irresponsibility, immorality, mass corruption and humiliation under us, selling the property of our country and its resources to the right and to the left.

Clerks poke into our face without ceremony the acts about the taxpayers' responsibility for the tax law violation, which were accepted exactly by them. They always remind us for what and how they can punish a taxpayer.

They worked out our rights and duties as taxpayers in the documents "Protection of the Taxpayers' Rights within the Tax and State Control" and "The Instruction for the Taxpayer of the Country".

The terms of payment and methods of the payments collection by the tax collectors must be clearly determined for a taxpayer by a clerk of a fiscal institution. Everybody can hit into the power of a tax collector where it is not so. And he can increase the tax by a threat of financial and penalty sanctions application, trading with a taxpayer by this way and requiring a bribe for himself in a view of recompense or a bribe.

Only the death and taxes are inevitable for us, taxpayers of the country.

For example, it is celebrating so called Day of Taxpayer in Germany. All what the inhabitants of the country earned from 1, January, till 23, July, they give the state to support the clerks in a view of taxes and assignments, including the funds of the social insurance, which are leading by them too. The Taxpayer's Union Chairman Karl Heinz Decke ripped a symbol one hundred euro symbol banknote into two parts and put its smallest part to his purse during the press-conference in Berlin.

Every working in the country pays to the state to support the clerks 56% of his annual salary on average in a view of direct and indirect taxes, different assignments, including the medical insurance, insurance against unemployment and to the pension fund.

Many taxpayers even don't guess about the size of their tax burden. They can see the size of their income tax and their assignments in their salary bulletin. But there are also the indirect taxes, such as for the petroleum, tobacco, strong drinks, employers' dues to the social insurance funds, VAT.

The Taxpayer's Day, when they are beginning to work for themselves at last, is celebrating every year in Germany every year, but it turns out on the different dates. It is more moving to the second half of a year during the last time. This day had been celebrated still on thirty first of May in 1960 year.

The time to protect ourselves from the officials' despotism, short their customer requirements at the society and their general quantity at the state had been came for the taxpayers of the world.

For example, we, taxpayers, pay about 10 millions USA \$ every year to support the officials and to create new jobs for them in Ukraine only. However the data of the force institutions – MIA, SSU and the Ministry of Defend – don't publish, but it is the same sum more. As peoples' wisdom states, there are three foremen for the every slave. These expenses grow at the state, but there are no effect for the taxpayers from it, and cannot be of course.

There are representative expenses, different discounts providing, phone services, transport, air plane tickets expenses, salaries and compensations, apartments, pensions and different kinds of financial aid etc are within these sums. The state debt of Ukraine had been enlarged within the last 20 years of their governing. Its size is already 100 billions of USA \$. There is the same sad situation with the clerks maintaining in other countries of the world, and sometimes it is even worse.

Taxpayers of the countries must put the end to this anarchy, create their people parties and lead their representatives and anti-crisis managers to the state positions, taxpayers from the party who can increase the economical level of the country, provide the budget sources control and solve all the social issues at the society.

It is necessary to determine after all social programs at the society financing problems decision which quantity of the clerks at the state the taxpayers can afford to support themselves, and what size of the salary to pay them, using the residual principle.

It must be worked out the scale of financial stimulating of the clerks' work in accordance with this work results during a year or with a result their presence in the authority system and it must depend from the quality and effect of their work to the taxpayers' profit.

The state must not pay for the clerks' work at the non-industrial area in 10 and 100 times more that the work of a worker of the industrial economical sector of the 5-6 category in the hot network. There is the mass discredit and degradation of the highly-skilled working professions at the state, exactly at the industrial sector of the state economics.

The industrial economical sector at the state is destroying with the working places and working dynasties and with the highly-skilled specialists of the country without taxpayers' agreement.

The officials-minions don't think about their country future, the current profit satisfies them, as well as a possibility to snatch a large sum and run away with impunity. And if a corrupt-official feel his impunity and decided to stay in the country at all, he creates an organized criminal group (OCG), looks for his supporters-corrupts at the authority at the higher ranks and goes on to do the huge illegality, and a taxpayer has to pay for it.

The level of the salary of the officials, which were leaded to the authority by a taxpayers' party or by other political structure and organization, must be equal to the level of the salaries to the base part of the people at the state and can't be more than the double average statistical level of a salary in the state at the first stage And the party must bear the responsibility to the people for their activity quality. The budget resources of the taxpayers must be leaded to the economical level increasing and the solving of the social problems at the society.

The Ministry of Justice and the Security Service of Ukraine is expedient to do the revision of all the officials' parties at the state for the purpose of accordance of them to the requirements of the law "About the Political Parties", because the biggest part of them is transformed to the legal mean of the shadow capital washing. All their muddy leaders and chairmen and their oppressing ruling clique are wishing to sell themselves to everybody to close the "budget hole" to the state budget in a secret of other members of their parties because of the financial problems within the parties which were appeared because of the non-purposed budget means using.

Many of them showed the addresses which don't exist, there are no them also in the addresses which were noticed at the Ministry of Justice, they have no a web-site, e-mail addresses and contact phone numbers. Nobody knows their tasks and program documents. And what are they doing?

At the period of the development of democracy in the state, it is important not to admit the raging of it and it's transforming to a mean of the parliament activity sabotage organization leading by one or several political forces, declared their opposition to the functioning government and the people, which selected them and appointed as managers – people's servants. The protest forms such as demonstrative abandonment of the collection hall and parliament building must be looked up as the people's trust neglect and it must be looked up the responsibility for these actions organizers.

There must be the measures of the criminal responsibility for the economical sabotage organizers.

The government must go in retirement for the legislation about the state budget acceptance terms violation, and the party which created it must be deprived a possibility to take part the election campaign at the nearest 6 years.

Strangely enough the authority which was elected by the people is working against the people.

It must be looked out the criminal responsibility for the people which have their fault in the no-purpose budget resources expensing with their property confiscation and the property of their direct and indirect heirs. The incomes and expenses of the officials must be controlled

by the state and taxpayers, the citizens who create the state budget and pay salary to the officials from the assignment from their salaries.

The officials create the months of the struggle with the corruption and declare that we're fighting with the corruption openly. It is our action! We provide you a possibility to collect money, and you'll bring us a bribe in two times more at the next time.

It is already the time to finish with it and introduce amendments into the Criminal Code of Ukraine, exactly the articles which are connected in any way with the economical crimes and the brought consequences to the state economics, the articles, where is remaining the punishment term for the economical crimes at the state with the property confiscation. These articles must be added and supplied by the text "...with the confiscation of the property of direct and indirect heirs". The corruption will die forever afterwards.

All the property of direct and indirect heirs of the guilty criminal must be arrested till the moment of the documental confirmation the property right of their owners and the origin of the financial resources in their property. It is impossible to present the property which had been pilfered from the people, collected by the impostors illegally and removed from the state economics.

The law of the energy keeping, including the finances and economics of any country, states that "nothing appears from anywhere and nothing takes from the air, and nothing disappears anywhere, which is the most important". Therefore it is always an economical trace of the derivative of the financial values of every citizen of the state.

Executing the presumption of innocence, every citizen of the state has a legal possibility and may get a letter of credence from the state as a fiscal institution for his property and prove the law-court the way of his property appearance as well as the property of all direct and indirect heirs of the criminal who is attracting to the criminal responsibility.

Why the officials must do "a spectacle", which is so called months of the struggle with corruption if we can simply destroy it and show to everybody that the laws in our country can work and protect the taxpayers? We'll do the full inventory of the state property at the same time, find non-liquids at the enterprises which were not pilfered yet, understand where they are already disappear and where are the remains of the economical poverty of the formed country hidden. All the social-economical program and reforms are described and presented to the world society as an example to everybody at the "Aspects of Ukrainian Economics Reforming". In this document every country of the world can find national ideas of the economical perfection of the state development for itself.

It is purposeful to create a social organization "The Center of Taxpayers' Rights and Freedoms Protection" at every country which participates at the "Life" project.

The category of the global logistics (“harmonious” and “network”), i.e. the operative contact with the partners, clients and customers of all the levels and all the world countries also concern to the neo logistics.

The Chaos Theory is the area of researches, combining mathematics, physics and philosophy. **Chaos** is the higher stage of the order, where absence of pattern and a chance are the organizing links as the opposition to the causal-effect relations. *There are five main chapters of the human’s activity*: the social sphere, business community, mass media, party and social activity, state and municipal managing. They are also the area of researches of our specialists in all the fields of the Transnational Project “LIFE”, including the searching and appointing of the people on the criteria of their professionalism, which are the competence, maturity, active life position and intellect.

The Chaos Theory is the mathematical apparatus, describing the behavior of some dynamic systems, which are the subject of the involvement famous as chaos under the determined conditions. This system’s behavior seems to be casual, even if a mode, describing the system, is the determined one.

Atmosphere, turbulent streams, biological populations, society as the communications system and its subsystems, such as economical, political and other social systems are the examples of the written above. Usually the researching of these involvements accompanies by the mathematical modeling together with the analytical exploring of the existing recurrent relations.

The Chaos theory is the area of researches, connecting the mathematics, physics and philosophy.

The Chaos Theory states that complicated systems are extremely depending from the primary conditions and small changes at the environment are leading to the unpredictable consequences.

Mathematic systems with the chaotic behavior are determine, which means that they subdue to some strict law and they can be called ordered in some sense. This using of the word “chaos” differs from its ordinary meaning (see “chaos” at the mythology). There is also a

field of physics as the theory of quant chaos, which researches the non-determined systems, subduing to the laws of quant mechanics.

French physic and philosopher Anri Poincaré (which proved a theorem about return), Soviet mathematics A.N. Kolmogorov and V.I. Arnold, Moser, created the chaos theory called KAM (Kolmogorov-Arnold-Mozer's theorem) are the pioneers of this theory. The theory enters the conception about attractors (including the strange attractors as attractive Cantor structures), as well as about stable orbits of a system (so called KAM-tors).

The word "chaos" means "to be in disordered condition" at the ordinary meaning. The adjective "*chaotic*" had been determined more correct at the Chaos Theory. Though there is no the generally accepted mathematic determination of the chaos, the using determination states that a dynamic system classifying as a chaotic one, must have the next properties:

1. It must be sensible to the primary conditions;
2. To have a property of topological mixing;
3. Its periodical orbits must be compact everywhere.

The line systems are never chaotic. The dynamic system must be nonlinear to be the chaotic one. In accordance with the theorem of Poincaré-Bendixson the persistent dynamic system on flatness cannot be chaotic. Non-planar spatial systems have the chaotic behavior within the persistent systems only (presence of not less than three dimensions, or non-Euclidian geometry). However the discreet dynamic system can show the chaotic behavior on some stage even in one-dimension or two-dimension space.

To understand the Chaos Theory of B. Williams correctly, it is necessary to investigate this conception determination. Traditionally, people understand chaos as a disordered structure, though its essence is rather directly opposite to the chaotic character indeed.

Chaos is the higher step of the order, where organizing links are absence of pattern and chance as the opposition to the causal effect.

Chaos is steady, stability is temporarily. Financial markets are a product of chaos. The reason and consequence are predictable at the line world. There are no these relations between the reason and consequence in the non-linear (real) world. Therefore, by the point of view of B. Williams, the using of fundamental and technical analyze doesn't allow to get the profit at the financial market regularly.

In accordance to the chaos theory, an investor, who spurns from the linear perspective, will never see the "real" market, and therefore he has a risk to bear the permanent loss. The chaos theory refutes a fact which is the base of technical analyze: the further behavior of the market will be like the previous one. Bill Williams thinks, that the reason of a fact that traders lose on the market is a fact that they often too much trust in the different kinds of analyze, which "are not active indeed, and therefore are purposeless and even dangerous", as he thought.

New logistics is the logistics of the second generation, for which it is typical on the first stage (1980-1985 years) enlarging of the sphere of the compromises activity at the logistic conception, complex approach to develop the logistic systems on the base of the all enterprise, based from the general purpose to achieve the maximal effectiveness of the activity of all enterprise predominance.

There was began the second sage of new logistics since 1986 year. During this stage the complex approach has got the new development in a view of conception of the “general responsibility”. The criterion of the “general responsibility” conception is the maximal correlation of the exit and expenses. Within this approach the logistic systems went out the borders of the economical sphere and began to take into account the social, ecological and political aspects. By the new point of view logistics from the level of firms (micro level) can go to the branch (meso level) and even to the level of the state property (macro level). The categories of the global statistics, logistics of the “harmonious” (thrifty) industry (in accordance with B.A. Anikin) and the network logistics (operative contact with the partners, clients and customers of all the levels) are also relating to the second stage of the new logistics.

The transport-logistical complex (TLC) is created on the principles of the new logistics. TLC has the two goals: financial, industrial-technical and the technical one. TLC is made of such subsystems as the terminal complexes and elements of the logistic transport network. Freight owners, rail ways and other kinds of transport, providing the freights deliverance processes can be the elements. TLC has in its structure the divisions, doing the marketing exploring, which can give the information to accept the compromise decisions.

At the conditions of a non-stable external midst it is using not efficient strategic managing, but more effective strategic enterprising, which takes into account all the complex of factors and which is the main instrument of the synergy achievement at the multilevel TLC.

As an example, there is a network of transport regional logistic centers in Russia. The first of them is at the Republic of Tatarstan. The second one is creating at the port of Nahodka, and the third one is in Rostov-na-Donu.

There are two of them in the regions of Saint Petersburg and Moscow at the stage of negotiations else. These logistical centers are a good stimulus for the economical development of the country and the relations consolidation with the world logistic network within the conditions of globalization.

The period of the logistics of the second generation is the third one at the history of the logistics development. The first period (till 1950 year) is calling pre-logistical. The managing by the material streams during it has the fragmentary character. The coordination of the divisions of the firms is not enough. The second period (end of 60-s – end of 70-s years of XX century) is possible to count as the period of classical logistics. It characterizes by the creation of the logistic systems at the firms instead of the optimal transfers organization. At that the complex approach to the process of the goods movement and compromises using are having place.

The large populating of the regional logistic centers (especially at the pedagogical logistic) can lead to the new logistics of the third generation, which is the logistic network (from the universal regional logistic centers – URLC), as well as to the virtual logistics, the logistic of a state (authority), the city logistics.

So, the transnational ecological, legal-economical project “LIFE” is created on the base of neo logistics and the Chaos Theory, researching area, connecting mathematics, physics and philosophy. They are used to solve the “fundamental problems of the hydrogen energetic”, hydrogen-atomic, hydrogen, alternative, refreshing energetic and fuel elements, Nan systems and nanomaterials industry, quant points and fuel elements, including the

Any political party can't state that their party unites everybody who is the economical ground of the state and the inexhaustible source of the state budget filling, i.e. taxpayers in contrast to the All-Ukrainian Taxpayers Party (AUTPP) and national parties created at the world.

All the officials' parties, struggling to the authority between them, carry the dissidence to the modern multinational society which is not protected socially. These parties are the sector ones. They seize those electors and that electorate who sold to them or officials who is guilty in something to the “Owner”. They have no their ideology, they have no the people roots, a national idea, all is on the words only, excepting the wish of their leader to sit into this or that state armchair. Hiding by the words about the struggle for the people ideals, the

officials rob the state, sell the national interests and the raw material resources, sit on the budget financial streams and rob their people.

The officials use the people for the solving their low and merchant interests and to take the authority at the state using the taxpayers which is the most important.

As in Ukraine, the officials in the world countries create the new job places for themselves, but not if only for the labor people. It is necessary for the parties' owners, high-rank officials of the authority to buy already today the votes of electors in the regions where they appointed their representatives. They do their dirty affair, attracting the administrative resource (officials – vassals) to collect the votes to support the necessary candidate at the elections.

The Government, the President and the political parties didn't create the new working places at the real economical sector. The people money is going to the struggle with the people, to the suppression of the non-agreed taxpayers' actions within the struggle with the officials' authority, despotism and despotism, and to finance the confrontation between the parties at the society.

The taxpayers of Ukraine as of all the world countries are the economical ground of the state and the source of the state budget creation. Exactly they create the political, economical, legal and military potential of the state.

Exactly they are the inexhaustible source of the economical development, prosperity and power of the country.

Taxpayers, remember that the budget will not be shorted if there will not be enough money for the clerks' salaries. But the social programs will be detruncated. The more clerks will be on your maintenance than less will be corruption at the state. It is the truth which doesn't needs evidences.

Taxpayers, the main enemy which exists all over the world is a clerk – bribe-taker, living at the expense of others, a dependant, a mediator between the people and the authority, a traitor of the interests and ideas of the people-creator and worker!

Today it is necessary to build the new factories on the Hi-Tech base, to create the new well-paying job places for the population of the country. In accordance with the data of a Gallup poll, the opinion of "little Ukrainians" has changed cardinally during the last 10 years about the degree of honesty of the local and central authorities.

The first ones had confidence in 1999 year, but people don't trust at all to somebody in 2009 year, even to the central authorities.

If 10 years long ago 36% of the people believed in honesty of the local authorities against 15% of the central institutions, there are 34% – 50% are against the central authority institutions now. And there are 12% of the population only who believe in the local authority.

It was the same situation with the authority effectiveness scoring: 24% against 16% to the profit of the local supervisors in 1999 year, and 3% to the profit of the rulers from Kiev in 2009 year.

However the most important figure is completely the other: about 50-60% of the citizens of the country don't trust into anybody as 10-15 years long ago as now, because there are false, corruption and the cover-up everywhere at all the levels of the authority.

In accordance with the different scores, 50%-60% of the taxpayers which don't trust in anybody are the serious verdict to the result of the governing of V. Yuschenko's, Y. Timoshenko's and the officials from their command.

In accordance of the "Center of the Taxpayers' Rights and Freedoms Protection "LIFE"", there is 34%-50% of the population of Ukraine who don't trust the officials and the authority, and if we should add people who find difficulty to answer and don't wish to take part the adventurous elections, this figure will be more yet.

More than 78% of Ukrainians don't trust in the law-courts and the police.

The trust absence champions are the law-courts and the law-enforcement.

The managers-officials, the state managers of the different levels, guilty at the non-effective governing by the state actives, at the defensive capacity lowering, nuclear, ecological and economical safety of the country by this or that reason, must stand at the taxpayers' court and response together with their mates for all their crimes.

The peoples of all the countries and taxpayers of 90 countries wish to see openly all the managers who are guilty in the life level lowering and its duration and also people who are guilty in their poorness and destitution. It is the time to attract to the responsibility with the world community participation and to return all what was robbed by them to the economics of their countries which is the most important. It is also the time to investigate the magnates' illegal capitals collection, the legality of the state property bargaining. And it is the time to investigate why are the intellectual property, patents, inventions, NOW-HOW, which are in the privatization objects' property, not included to the value of the privatizing and selling objects.

This is exactly the subject of the dispute of the new owners with the taxpayers, who lost their jobs, property, which was collected during many years, and became in the street in misery and poorness.

But what is the role of our state in this case and the people authority delegated by us, how do they protect our rights and freedoms? It is nothing. They use the people authority, which was provided them by us, in their merchant purposes, and it is the fact.

Hiding behind the immunity of the deputy which was provided by the people and which must be cancelled as soon as possible, and behind a fact that a law hasn't a vice versa force, they are doing the terrible things and illegality. It is the time for the taxpayers of the country to put the end to this matter and to ask all the bad rulers-managers, who were employed by the

people to their job, where does the economical might of the state disappear, and why do they getting wealthy personally at the time when we're getting poorer.

Used our trust, the officials fabricate the criminal affairs, trim the bribes, destroy and beat us, take offence and debase us. And all of it is doing openly, in the view of the world society. Exactly by this way the officials, so called "the political elite" of the states, possessing the real authority, made us their slaves in our state, declaring that the authority belongs to the people. We must struggle for our rights and freedoms to finish it. The officials will not stop to command us voluntarily.

It is the time for the world community to unite within the World Assembly of the Taxpayers' Parties (WATPP) and to appoint everything to its places.

An official of any rank must know that he is a servant of the people and a manager employed by the citizens of the country, by the taxpayers, to manage the state people actives. It is nothing as the hidden slavery, existing in any country of the world, and it is in the time when there are the elected parliaments working which were elected by the people, where the officials sit again, delegating the authority from one generation to the next one, to their caste and their official parties only. There are no the people parties indeed in the world, we must create them, taxpayers of the countries, it is the time to take the authority in our hands and put a place in order.

Taxpayers of all the countries, unite!

More than two thirds of Ukrainians (73%) suppose that the deputies, who were elected by the people, are unable to protect the interests of their voters.

At that more than 84% city inhabitants even don't know who their deputy is. The detailed data is so: 84% at the Supreme Rada, 86% at the Regional Rada, 88% at the City Rada.

It means the secret lists, bought positions, dictate of the parties' rulers, cult of personality, feudalism in the society, dissidence of the country!

But it is a more horrible result else. The opinion which states that the deputies cannot protect the interests of their electorate, had got the biggest spreading among the staff ... of the state management, and 88% of them refuses the deputies in a possibility to lobby the voters' interests.

The people deputies state sometimes, “They don’t listen to me”. It is funny and sad, isn’t it? Who do we elect and who does protect our rights and freedoms at the society?

Impunity and permissiveness of the officials is rooting the detestation and contempt of the people to them. The people will lead from the words of detestation to the real acts and begin to beat them on their heads for the money which they pay them in a quality of the reward, and which they don’t work off and even pilfer and require the bribes, mock and jeer at the taxpayers of the country. It will be the graceful time in all countries of the world, thankfully at the untalented officials of all the ranks, when the people, took the pitchforks, will look for the fat sides to insert them in!

If there were 18% of the citizens only who confessed of a fact that they had to give bribes in 2007 year, but now their quantity increased till 39%. These data the “Center of the Taxpayers’ Rights and Freedoms Protection “LIFE”” got, compared its results with the Center of Anti-Corrupting Researches Transparency International – Russia (TI-R) at the report “The World Corruption Barometer – 2009”.

Judging by the data of the questioning of the “Center of the Taxpayers’ Rights and Freedoms Protection “LIFE””, Ukrainians have to give bribes to the staff of the law-machinery most often – 36%. 29% of the people took part at the questioning, have an experience of the necessity to give the additional reward to the staff at the medicine and health care area. 26% has this experience at the structures responsible to the land relations, and 24% has it at the education area.

Answering the questions of the Center “Which is the most corrupted sphere from the following social ones in accordance with your opinion?” Ukrainians named officials who are working at the state service – 84%, law-courts – 64%, the Supreme Rada and the political parties – 62% and 61% accordingly, as well as business – 55%.

The state debt of Ukraine (general and guaranteed) had been counted. It is unexampled for such economics as the Ukrainian (transition) one.

It will be necessary to pay about 6 billions of UAH to serve the internal debt, which is the half of incomes of the general fund of the state budget.

To imagine the size of the internal debt it should be noticed that it will be necessary to pay about 6 billions of UAH to serve it, when the size of the incomes of the entire state budget fund is about 12 billions of UAH. It means that the half of the incomes must go to the debts payment, and it is also necessary to pay the Russian gas about 12 billions of UAH.

It is significant that the state debt level was in the size of 32, 9% of the national produce in 2009 year. The government has returned 31, 3 billions of UAH of the state debt in 2009 year, if not to count the corporative debts of "Ukrainian Auto Roads" and "Ukrtelecom".

By the state on 31, January, 2010 year, the state and guaranteed by the state debt was in the size of 301 milliard, 538 millions 747,28 thousands or 37 milliard 686 millions 690,45 thousands of USA \$, including the given below.

The state and guaranteed by the state debt is 195 milliards 286 millions 531,9 thousands of UAH (64,76% of the total sum of the state and guaranteed by the state debt) or 24 milliards 407 millions 155,45 thousands of USA \$.

The state and guaranteed by the state internal debt is 106 milliards 252 millions 215, 29 thousands of UAH (35, 24%) or 13 milliards 279 millions 535, 00 thousands of USA \$, by the data of the Ministry of Finances.

The state debt of Ukraine was 212 milliards 133 millions 243, 00 thousands of UAH (70, 35%) or 26 milliards 512 millions 678, 50 thousands of USA \$.

The state external debt was 119 milliards 939 millions 835, 96 thousands of UAH (39, 78%) or 14 milliards 990 millions 230, 97 thousands of USA \$.

The state internal debt was 92 milliards 193 millions 407, 8 thousands of UAH (30, 57%) or 11 milliards 522 millions 447, 53 thousands of USA \$.

We'll remind that the state debt of Ukraine was 205 milliards of UAH by the state on 31, October, 2009 year by the data of the Ministry of Finances.

The state external debt of Ukraine was 121, 36 milliards of UAH, the state internal debt was 83, 67 milliards of UAH.

The combined state debt of Ukraine was enlarged on 40% during the 2008 year, and it was enlarged on 41, 9% else in January-September of 209 year.

Having 40% of the world reserve of polymers, we are beggary. There is 40% of the world reserve of the black earth in our country, but we import potatoes, carrot and all vegetables by the unimaginable price from abroad. The agriculture, breeding, poultry keeping and the sugar industry had been completely destroyed at the state. And the officials are guilty in it themselves; exactly they destroyed the state economics to please the same people as they are. And it is their crime to the native people.

The half-measures are not enough here. The taxpayers must take the authority at the state!

We bring to the entire world the new national idea, for the people from all the countries. The project models the new political, economical and legal thinking, the new ideology of the taxpayers of all the countries of the world.

The officials of the lower level. The garbage of the business.

The ordinary citizens' disposition to the authority is based on two parameters. There are the personal experience of the contact with the officials and the observation of the high rank officials' activity through the prism of mass-media, including the radio and television.

To tell about the local officials, one my colleague of high-rank from Kiev city administration contemptuously called them "The garbage of business". Truly, the lower level of the state clerks is very primitive judging by their educational and intellectual level. As a matter of fact, the pump of the "private enterprising" leaded out all the talented and practical persons from the state structures, remained only those people who have no place to go.

For one's turn, the remained people have tried to fill in the holes around them by the same nonentities, pressing and expelling from their community honest and practical persons. No wonder, that our citizens get a refusal to their legal requirements at the level of the contacts with these people in 99%. The reason is in a fact, that one of the key rules of a lower official states, that you're avoiding of the risks and mistakes, refusing in 99%, and, so, you're nearly right on 100% from the point of view of your functions executing, and you're risking by nothing. I.e., the function is creating an organ, as at the primitive physiology.

The officials of the lower rank were grew from the media of the heads of divisions and departments, remaining the same "younger engineers" at essence, which they were all their life, even when they were 50 years old. By the principle of the rats' king, these people are the sliest from the sliest ones, which, properly speaking does the struggle with them on the places so difficult and complicated. Properly speaking, it is one of the reason of a fact, why nobody struggle with the officials' despotism, preferring to accept annually the more and more stern declares and decisions "on paper". Therefore AUTPP and WATPP are going to change everything to the best, with support of the taxpayers of the country.

It was like an anecdote during the periods of L. Kravchyuck's, L. Kuchma's and V. Yuschenko's governing, that 40% of the State machinery clerks haven't the higher education. The Minister of Justice, the Deputy of the SSU Chairman and others were without the higher education. The current situation at the places became more difficult, especially at the professional aspect; when the officials are showing off their intelligence sometimes even without the documents about the higher education, under the covering of the President and the Prime-Minister.

The country is crushing, nothing is being changed, there are the same problems, and the silly but greedy officials are the same ones. The country and taxpayers have to see these replete and satisfied faces on the television, which are showing them at talk-shows, at the Supreme Rada, boasting in front of the sophists, stating sometimes not silly only, but even raving ideas and thinks, spending the taxpayers' money cruelly. Office-cleaners as the lowest caste of officials is retiring on the pension, managers, managers-clerks of the organizations, ministries and institutions are changing together with the authority, but the middle link of the excessive clerk staff of the organizations are remaining, and it is impossible to chuck them out.

But WATPP and AUTPP will do this wonder; we'll put a place in order in our country and help to the brotherly peoples. The staff policy from a metalworker to a minister justified itself. A human who never worked at the real sector of economics, must not be maintained by the account of the taxpayers and be the eternal dependant of the people. Pension must be

earned by all the people at the real economical sector only, without the restrictions to the payment, with exception of the professions of military, teachers and doctors.

The length of service in the officials' positions must not be taken into account to the general seniority, with exception of a rarely causes by the results of the qualitative work on the profit of the people and the state, and if it had been decided to encourage the official as an effective manager and to pay him a large financial reward in accordance with the taxpayers' application.

The officials of the high rank. This work is like a show.

But to tell about the officials of the high rank, there are gifted people undoubtedly, but their talents are expressing not into the professional anti-crisis management area, but into the sphere of public appearances both to the people and their chiefs. There are the skills of people manipulation and to present the life as a show, appearing in the forefront here, but not the professional skills. These people are extraverts as a rule. These people can also master a profession of a toast-master, social organizer or an artist easily.

Not without reason an actor Reagan has become the President in his time, and an actor Schwarzenegger had been elected to be the Governor of California. To tell about Russia, an actor and a humorist Mikhail Evdokimov (was perished on 7, August, 205 year in a car accident near Biysk) has become the Governor of Altai Territory. Mikhail Shwydkoy is continuing to be in the position of the ARSTRC and to be a showman absolutely calmly in Russia.

There are one's own not the people artists, but "the artists of their people" in Ukraine. These artists of L. Kravchyuck, L. Kuchma sang well and spilled vodka into liqueur-glasses as virtuosos. The Prime-Minister Y. Timoshenko, rulers' and the highest officials' from the authority wives appeared on public to boast in front of each other, who was wealthier and who did pilfered from their people more. They are dressing in furs and brilliants without the conscience view to the current elite party (so called bomond community), humiliating and offending the poor and hungry people. But even they are showing a signal that there are problems in our society today too. This signal indicates that the people will not endure it more, that everything in the country will be erased because of the officials' fault and silly supervisors. And the taxpayers have no doubts in a fact that the offenders will be punished by the strictest way.

V. Yuschenko has got out from Ukraine by two transport airlines antiques, furs and other material actives, gifts which were presented and handed to the President of Ukraine from the Heads of states, governments, Ambassadors of the foreign countries, legal and physical persons, to Canada and to the USA (to Chicago).

All the actives which were got out are counting as "green peas" at the customs documents!

Is it not a mockery above the Ukrainian people?

The verdict of the international law-court to the torture or the life imprisonment for the formed leaders of the countries at the genocide of their people and plundering of the state is becoming a norm at the last time.

By the conclusion of the international experts, thankfully the World Assembly of Taxpayers Parties, this fate and fortune will be prepared by the culprits of the people grief

It means to arrive to the accident place in time, to make a sad face and to say the farewell words at the grave, to promise the aid for the victims and the members of the families of the decedent people. The placid life of the high officials is going from a cataclysm to a cataclysm. The money from the budget is picking out, but somebody is making a profit out of the people grief, and the money doesn't arrive to the people.

The officials' image in the citizens' opinion.

The image of the Ukrainian officials in the opinion of the population of Ukraine is completely awful, especially if it would be compared with their imagination of an official in Western Europe.

If the leading qualities of a Western-European official from the Ukrainian point of view are the competence, efficiency, culture and education, responsibility and reliability, creative potential and incorruptibility (there are no a negative one among the eight dominant qualities), the portrait of his Ukrainian colleague is the completely opposite one (let's say it directly). He is characterizing by his apathy to the people, corruptibility, and indifference to the interests of the state, irresponsibility and incompetence. We inherited it from the previous regime of the authority, and it will be a grief for everybody of us and our next generations if we will not break this stereotype.

Therefore it is necessary for everybody to unite around AUTPP and WATPP, to give the adequate repulse not to the stupid officials only but also to the authority which is presenting by them.

A vicious circle is creating: on one hand, the authority and the officials ignore the interests and rights of the citizens, on the other hand the most part of the citizens are paying them by the same coin.

Besides a fact that they create the most negative image of the native bureaucracy, they also try to avoid legal or law methods of their current problems solving. If it is possible not to contact with the state official, this possibility is using for 100%. The officials themselves, of course, see them completely differently. They are sure that professionalism, knowledge of their area, diligence and capacities for work are their main qualities in the view of taxpayers and the society.

There are also different opinions about the reasons of non-effective activity of the bureaucracy. The ordinary citizens are sure that the main reason is in the officials' impunity. Carelessness and the low moral level are the others reasons of it. Officials, for their turn, put the laws imperfection on the first place; on the second place they put the big size of their work, and on the third place is the low level of their salary.

At that (pay attention!) to all the aspects of the life satisfaction the officials pass ahead of the main part of the population in several times. They are satisfied by the level of their comfort, a possibility to buy clothes, to feed on, to use their leisure pithy, to travel for their rest.

By the way, it leads to a fact that young people think that to become an official is prestigious. But as the salary there is "not high" to their criterions they will "have to take bribes" willy-nilly, and I think that it is one of the priorities for the youth to be an official in their country. So, the society degrades in the state under the leading of the social awareness disfigured by the society, and the non-industrial professions find the veiled respect. The prestige of the work professions had been destroyed by the functioning authority at the educational institutes.

Inefficiency of the officials' work and their incompetence are creating the distrust of the society. The social distrust creates the defined image of the officials' community. People who try to get the officials' positions have a kit of personal qualities, adequate to this image: "I must be ready to everything to hold in the warm position", "a low salary means a possibility (and even the necessity) of an additional income" (which the bribes are), "I must do everything to avoid the responsibility, and if it is not possible I must do everything to eat as big piece of the cake as possible till there was no clap". It is possible to change the existing order of the life if the system of the recruiting to the responsible positions will be completely changed. We see the role of AUTPP exactly in it. There are the multilevel exams even now in China, which must hold a human, pretending to the official's position.

May be the taxpayers and legislators should think about it? Who is governing by the state and by us?

Perhaps, the key reason of the deplorable quality of our officials' machine is hiding in the twisting ways of the human resources recruiting to the executive authority institutions, which are creating the defined psychological type of an official. The human resources structure is leading in our country by the principle of the devotion to a political leader, feudal lord, dictator etc.

Taxpayers! Let's maintain those people only who truly protect our rights and freedoms, who serve us, the Ukrainian people, and taxpayers.

What will you bring to the top, to the higher official, if nothing attaches to your hands? You are an official not for this goal, and you was appointed to the authority not for this, and the profitable and corrupted position was created under you for you to pilfer.

Ask you a question! Who is heading Ukraine today?

The President, the Government, the Parliament, the leaders of the parties, the political elite and their surrounding.

In point of fact, they are the officials-managers, appointed by the same officials, but not by the people. They created themselves and appointed to the highest positions, deceived their own people! They wrote for us, taxpayers, the strict laws and they strictly observe about their execution because they need us to maintain, to keep them, to provide discounts, transport, airplanes, connection for the and support till the last day of their life, paying them huge pensions. This is the clan policy of the officials!
